### **Cancellation policy:**

- Mission Ridge Stables <u>cannot provide refunds</u> or guarantee makeup classes if a client misses a class due to illness, injury, appointments, vacations, other commitments, etc.
- If Mission Ridge Stables must cancel a class due to extreme weather, poor air quality, instructor illness, or other circumstances outside of the Stables' control, the client will be credited on the following month's invoice.

### **Inclement Weather policy:**

• When the air quality index is 7-10 or higher, there is a base temperature of -25 or colder / 33-35 degrees or higher, or other extreme weather making riding dangerous for horses and humans, clients will have a ground/theory lesson & will ride when conditions have improved again.

### **Important Information:**

- Mission Ridge Stables runs an inclusive riding program that includes ground and theory lessons intermittently throughout the year even without inclement weather. These are valuable lessons for developing horsemanship and well-rounded riders.
- Riders are strongly encouraged to purchase their own ASTM/SEI approved helmets. These can be purchased at Greenhawk, G&E Pharmacy, or online from Amazon.
- All students are required to wear long pants as well as a boot with a ½ inch heel. Long sleeves are encouraged. Crop tops are not permitted for riding.
- All students are asked to arrive on time: 5-10 minutes prior to the start of their lesson time. If they are helping with tacking up horses, they must arrive a minimum of 30 minutes early.
- Registration is on a first come, first serve basis
- Registration is considered continuous please **provide 3 weeks written notice** for any changes to enrollment.
- Instructors will do their best to assign students to horses that match their abilities and personalities. Riders are not guaranteed to ride the same horse every week
- If you have any concerns about your child's lessons, please speak to the instructor first. If the problem still has not been resolved to your satisfaction, please reach out to management Roxanne at 780-953-2251
- Parents may watch lessons from inside the heated lobby, or from the side of the arena.
  - Note if watching from the side of the arena: Children are easily distracted by their parents. As a safety precaution, and out of respect for instructors, please refrain from speaking to your child while they are riding photos/videos/words of encouragement however are of course encouraged!
  - If a child falls off their horse, please do NOT enter the ring until the instructor says it is safe to do so

The undersigned acknowledges that activities undertaken at the facility and lands of Mission Ridge Stables have inherent risks. Mission Ridge Stables will endeavor to provide reasonable services and to act reasonably, although Mission Ridge Stables is not able to assure you that the services they, or anyone else at Mission Ridge Stables facility or associated lands provides or the horses and animals at Mission Ridge Stables will meet your needs or provide a trouble free or risk free experience.

The undersigned releases Mission Ridge Stables, its directors, agents and employees from all liability and waives, as against Mission Ridge Stables its directors, agents and employees all recourse, causes of action or claims of any kind for loss or damages, including any consequential loss or damage, arising from the presence or activities of the undersigned, or anyone for whom the undersigned is a guardian or caregiver at Mission Ridge Stables or any associated lands, and voluntarily accepts the legal risk associated with the presence or activities of the undersigned or anyone for whom the undersigned or a guardian or caregiver at Mission Ridge Stables facility or associated lands, thereby expressly giving up any right of action from the physical risk arising from any actions initiated by the undersigned or, by anyone who is not affiliated with Mission Ridge Stables who is acting on the undersigned's behalf.

The undersigned further acknowledges and agrees that:

- Equestrian activities can be very dangerous and expose all participants or observers to many risks and hazards, some of which are inherent in the very nature of the sport.
