Course Description: *Mules & Martyrs, Inc.*™ is a proprietary, 3-day advanced interdiction training course that fuses the world of clandestine smuggling operations with the growing threat of religiously motivated extremism. Designed for interdiction officers, traffic enforcement Units, commercial vehicle enforcement officers, Intelligence professionals, Military Security Personnel and Homeland Security personnel, this unique course equips frontline responders to confront the evolving dual-threat landscape affecting North America today, enabling the attendee the ability to identify potential mass school shooters, homegrown terrorists, foreign ideological extremists cells, and politically radicalized actors, stopping them before they strike.

Participants will learn how to detect the clandestine tradecraft, smuggler behaviors, and the countermeasures used by smuggling organizations to avoid detection during traffic stops and interdiction encounters. These countermeasures—field-tested and layered—are used by sophisticated smuggling networks, many of which now operate in coordination with designated foreign terrorist organizations, including groups like Taliban, ISIS, IRGC and other extremist factions. With cartels now designated as terrorist organizations themselves, officers will be shown how smuggling corridors once used for narcotics are being exploited to move weapons, operatives, and ideology into the United States and Canada.

The course also provides deep insight into the radicalization pipeline—from youth indoctrination in the Middle East to online grooming and ideological manipulation of vulnerable individuals in the West for the purpose of committing attacks inside western countries. Students will explore how terrorist networks exploit social media, community grievances, and emotional trauma to influence and radicalize marginalized populations—including youth, immigrants, and disenfranchised citizens, inspiring them to become violent.

Through culturally grounded instruction, behavioral analysis, and video-based scenario deconstruction, attendees will gain the tools to recognize not only physical contraband or smuggling behaviors, but also ideological threats hidden in plain sight. This includes identifying radical belief indicators, recognizing nonverbal deception, and understanding verbal cues that reveal violent conviction.

By the end of this course, students will be better equipped to detect pre-operational behaviors, radical intent, and subversive movements before they escalate into threats against national security. The program's operational insights and field-tested methods make it an essential interdiction course for officers tasked with confronting both criminal logistics and ideological warfare at the roadside level.

Course Delivery Method: Lecture, pre-instructional strategy, class discussion.

- 10. Document and articulate behavioral anomalies and ideological cues in field reports.
- 11. Extract actionable intelligence during face-to-face contacts using proven interview strategies.
- 12. Interdict both physical and ideological threats while maintaining civil rights compliance.
