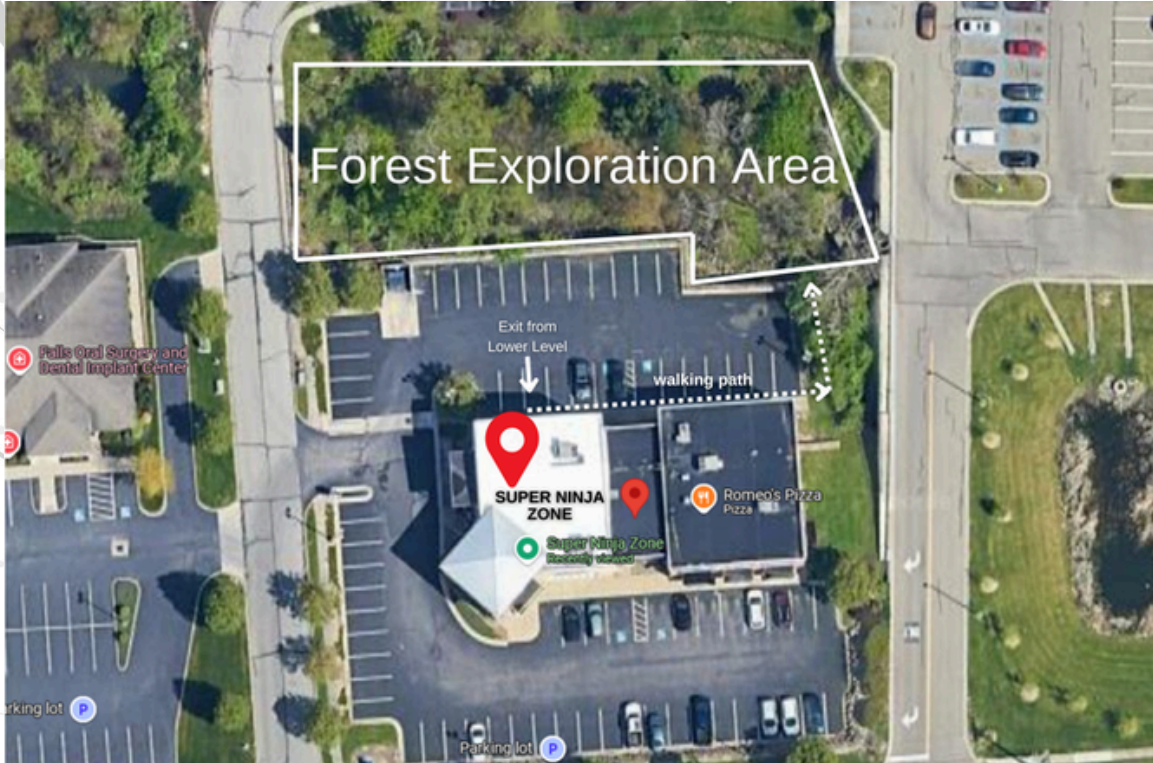

POLICIES AND PROCEDURES



We have a limit of 36 children in the facility at a time.
Spots are held on a first-come, first-serve basis.



How to Register:

Use our camp registration system here:

Child Eligibility Requirements:

- Children must be between the ages of 6 and 14, or Ages 5 must be turning 6 by September 1st, 2025 in order to attend.
- Children ages 5 turning 6 must have completed their first year of kindergarten to attend.
- Children are required to be able to use the restroom on their own.
- Children are required to be able to change their clothes on their own.
- Children are required to be fully potty trained.
- Children must have the ability to hold themselves up on the obstacles.

Age Groups:

Children will be divided into age groups for activities.*

Age Groups: Ages 5 to 9 and 10 to 14

On busy/full camp days of camp we divide into 3 age groups

Age Groups: 5 to 8, 9 to 11, 12 to 14

*May vary based on group sizes.

Attire and What to Bring:

- Please bring a water bottle
- Please bring your own sunscreen. Must sign a sunscreen waiver to have a counselor help apply sunscreen to your child.
- Please wear athletic shoes and clothes
- Half Day Campers: 1 packed Snack (Optional packed lunch for Morning campers)
- Full Day Campers: A packed lunch and 2 snacks
- An extra change of clothes in case of accidents.
- Please label all bags with the child's first and last name.

Pick Up and Drop Off

- Parent/Approved person (from registration) is allowed to drop off/ pick up their child.
- Children must be signed in and out daily.
- Children are not allowed to leave the facility/group unattended under any circumstances.

Counselor Information:

- All camp counselors are CPR and First Aid Certified
- Counselors are High School/College students who are interviewed and screened.
- Camp Counselor to Child Ratio is 1:10.
- All Camp Counselors are age 14 and older.

POLICIES AND PROCEDURES



Participant Rules:

Please review these rules with your children before attending camp.

- No bullying or harassment of any kind
- No weapons of any kind
- No play/pretend weapons
- No disrespect to Camp Counselors
- No damaging or taking Super Ninja World property
- No damaging or taking fellow camper's property
- Hands to yourself, no touching, grabbing, wrestling, or any physical contact toward other campers or counselors
- No foul language
- No leaving the group or the premises unattended unless signed out by a parent/guardian

Breaking the rules of any kind will constitute the following consequences based on severity:

- A verbal warning
- A phone call to the parent/guardian
- No field trip participation
- No games/activities participation
- A 1-Day suspension without a refund
- A week-long suspension without a refund
- A season-long suspension
- A permanent ban from Super Ninja World

Refunds

- Credit to your account is available in the event of sickness/illness
- Refunds are available in the event of an on-site injury that prevents the camper from participating
- No refunds for misbehavior that results in a suspension or early release.
- No refunds for no-call/no-show campers
- No refunds for lack of participation
- No refunds for lack of experience satisfaction

Field Trips:

- On Tuesday afternoons we take a routine walking field trip Cinemark XD in Cuyahoga Falls. It is located 0.3 miles from Super Ninja World. Participation in the field trip is optional. There is field trip fee of \$6 for the movie ticket. Each week we will watch whichever movies are available that are rated G and/or PG. Campers have the option of bringing money to make purchases at the concession stand.

Super Ninja World Day Camp Sickness Policy

Purpose: To maintain a healthy and safe environment for all campers and staff by establishing guidelines for identifying and managing illness during camp hours.

Policy:

- Health Screening:
 - Parents/guardians are responsible for ensuring their child is healthy before attending camp each day.
 - Any camper exhibiting signs of illness should not be sent to camp.
- Symptoms Requiring Immediate Pick-Up:
 - Campers exhibiting any of the following symptoms will be required to be picked up immediately:
 - Fever of 100.4°F (38°C) or higher
 - Vomiting or diarrhea
 - Persistent coughing or difficulty breathing
 - Unexplained rash or skin irritation
 - Pink eye (conjunctivitis) with discharge
 - Lice or nits
 - Severe sore throat or difficulty swallowing
 - Signs of a contagious disease (e.g., chickenpox, flu, strep throat, COVID-19)
- Notification and Pick-Up Procedures:
 - Parents/guardians will be contacted immediately if their child becomes ill during camp.
 - The sick camper will be isolated in a designated area while awaiting pick-up.
- Returning to Camp:
 - Campers may return to camp when:
 - They have been fever-free for at least 24 hours without medication.
 - Vomiting or diarrhea has ceased for at least 24 hours.
 - A doctor provides written clearance for contagious illnesses.
 - Lice treatment has been completed, and the camper is free of nits.
- Outbreaks:
 - Parents will be notified of any confirmed contagious illnesses at camp.
 - Additional precautions may be implemented per health department guidelines.

Policy Enforcement: Super Ninja World reserves the right to send home any camper who exhibits signs of illness to ensure the health and safety of all participants.

POLICIES AND PROCEDURES



Super Ninja World Camp Immunization Policy

Purpose: To ensure the health and safety of all participants and staff at Super Ninja World's camp programs by establishing clear guidelines regarding immunizations for children attending camp.

Policy:

1. Parent Acknowledgment of Immunizations:

- All campers must have up-to-date immunizations as recommended by the Centers for Disease Control and Prevention (CDC) and/or local health authorities.
- Parents/guardians must sign a statement verifying that their child's immunizations are up to date according to these recommendations.

2. Exemptions:

- Medical Exemptions:
 - Parents/guardians must provide a signed statement from a licensed healthcare provider indicating the medical reason for the exemption and the duration for which the exemption applies.
- Religious or Philosophical Exemptions:
 - Super Ninja World will review religious or philosophical exemptions on a case-by-case basis. A signed, notarized letter from the parent/guardian explaining the exemption is required.

3. Submission Process:

- The signed immunization acknowledgment or exemption documentation must be submitted before the start of the 2025 camp season.
- Documentation can be submitted via email, mail, or in-person at our facility.

4. Exclusion Policy:

- In the event of a vaccine-preventable disease outbreak, campers who are not immunized (due to exemptions or missing acknowledgment) may be excluded from camp for their safety and the safety of others. This decision will be made in consultation with local health authorities.

5. Record Retention:

- Immunization acknowledgment forms and exemption documents will be securely stored and maintained for the duration of the camper's participation in Super Ninja World programs.

6. Notification:

- Parents/guardians will be notified of any changes to the immunization policy or requirements in advance of camp enrollment.

Policy Enforcement: Super Ninja World reserves the right to deny enrollment or participation to any camper who does not comply with this immunization policy.

POLICIES AND PROCEDURES



Medication Policy

- Super Ninja World staff will only administer medications that are essential for a camper's health and well-being during camp hours.
- Medications must be provided in their original, labeled container with clear instructions for use.
- A completed and signed Medication Authorization Form must be submitted for any medication to be administered at camp.
- 1. Prescription Medications:
 - Prescription medications must include a pharmacy label indicating the camper's name, medication name, dosage, administration schedule, and prescribing healthcare provider.
 - Medications must be stored in a secure location and administered as directed.
- 2. Over-the-Counter Medications:
 - Over-the-counter medications will only be administered with written authorization from the parent/guardian.
 - Parents/guardians must provide the medication in its original packaging, along with specific instructions for use.
- 3. Emergency Medications:
 - Emergency medications (e.g., EpiPens, inhalers) must be readily accessible and labeled with the camper's name.
 - Parents/guardians must provide detailed instructions and, if applicable, a completed Emergency Action Plan signed by a healthcare provider.
- 4. Self-Administration of Medications:
 - Campers may self-administer medications only with prior written approval from their parent/guardian and healthcare provider.
 - Self-administration will be supervised by camp staff to ensure safety and compliance.
- 5. Storage of Medications:
 - All medications will be stored in a locked container or designated secure area, except for emergency medications, which will be kept easily accessible.
 - Refrigeration will be provided for medications requiring cold storage.
 - Documentation and Record-Keeping:
 - Staff will maintain a medication administration log to document each dose given, including the date, time, and staff member's initials.
 - Any medication errors or adverse reactions will be documented and reported immediately to the parent/guardian.
- Documentation and Record-Keeping:
 - Staff will maintain a medication administration log to document each dose given, including the date, time, and staff member's initials.
 - Any medication errors or adverse reactions will be documented and reported immediately to the parent/guardian.

POLICIES AND PROCEDURES



Medication Policy (Continued)

- Medication Pick-Up:
 - Parents/guardians are responsible for picking up any remaining medication at the end of the camp day or session.
 - Unclaimed medications will be disposed of in accordance with local regulations.
- Prohibited Medications:
 - Camp staff will not administer medications that are not approved by the FDA or prescribed by a licensed healthcare provider.
 - Herbal remedies, dietary supplements, or experimental medications will not be administered.

Policy Enforcement: Super Ninja Zone reserves the right to deny the administration of any medication that does not meet the above requirements or poses a safety risk to the camper or others.

Super Ninja World Emergency Preparedness and Response Plan

Purpose: To ensure the safety and well-being of all campers and staff during emergencies by implementing comprehensive procedures for evacuation, relocation, shelter-in-place, communication, reunification with families, and continuation of operations.

Policy:

1. Emergency Evacuation Plan:

- Procedure:
 - In the event of an emergency requiring evacuation (e.g., fire, gas leak), all campers and staff will follow designated evacuation routes to predetermined assembly points.
 - Evacuation maps will be posted in all activity areas, and staff will receive regular training on routes and procedures.
 - A headcount will be conducted before, during, and after evacuation to account for all campers and staff.
- Responsibilities:
 - Staff will assist children with disabilities and those with chronic medical conditions during the evacuation process.
 - A designated staff member will bring emergency supplies, including first aid kits, medications, and attendance records.
- Relocation Plan:
 - Procedure:
 - If the camp facility is unsafe, campers and staff will be relocated to a predetermined off-site location.
 - Parents/guardians will be notified of the relocation via text, email, and/or phone calls.
 - Responsibilities:
 - Staff will supervise campers during transportation and ensure their safety at the relocation site.

POLICIES AND PROCEDURES



Super Ninja World Emergency Preparedness and Response Plan (Continued)

- Shelter-in-Place Plan:
 - Procedure:
 - In the event of a hazardous situation (e.g., severe weather, toxic gas release), campers and staff will remain indoors in designated safe areas.
 - Windows and doors will be sealed, and ventilation systems will be turned off if necessary.
 - Campers will be kept calm and engaged in quiet activities until the all-clear is given.
 - Responsibilities:
 - Staff will ensure that emergency supplies, including water, snacks, and medications, are accessible.
- Communication Plan:
 - Procedure:
 - In any emergency, parents/guardians will be notified promptly via the camp's communication system (text, email, and/or phone calls).
 - Updates will be provided regularly until the situation is resolved.
 - Emergency contact information for all campers will be maintained and readily accessible.
- Reunification with Families:
 - Procedure:
 - After an emergency, campers will be released to parents/guardians or authorized individuals listed on the camper's emergency contact form.
 - A secure check-out process will be implemented to verify the identity of individuals picking up campers.
 - Responsibilities:
 - Staff will remain with campers until they are safely reunited with their families.
- Continuation of Operations:
 - Procedure:
 - In the aftermath of an emergency, efforts will be made to resume normal camp operations as quickly as possible.
 - Temporary adjustments to schedules, locations, or activities may be necessary to accommodate recovery efforts.
 - Responsibilities:
 - Management will coordinate with local authorities and service providers to ensure a safe return to operations.
 - Responsibilities:
 - Staff will ensure that children with disabilities or medical needs are prioritized and supported during all phases of an emergency.
- Training and Drills:
 - Regular training and drills will be conducted for staff and campers to ensure familiarity with emergency procedures.

Policy Enforcement: Super Ninja World is committed to adhering to this emergency preparedness and response plan to ensure the safety of all participants. Failure to comply with procedures may result in disciplinary action for staff or other corrective measures.
