By participating in the retreat, Participants acknowledge and agree to the following:

1. **Assumption of Risk:** Participants understand and acknowledge that participation in the retreat activities involves inherent risks, including but not limited to physical exertion, potential accidents, and unforeseen events. Participants voluntarily assume all risks associated with their participation.
2. **Release of Liability:** Participants release and discharge the Organizer, its affiliates, officers, employees, agents, and representatives from any and all claims, liabilities, damages, or demands arising from or related to their participation in the retreat, including but not limited to personal injury, property damage, or loss.

6. **Photography and Publicity:** Participants grant the Organizer the right to take photographs, videos, or recordings during the retreat and to use such materials for promotional purposes without compensation to Participants.

Liability Clause for Event with Alcohol:
