Kathleen searches for new ideas and decorations year round, always buys her decorations on sale and says that her biggest "score" ever was an 8' tall fully decorated tree for \$250 (originally \$1500), purchased the week before Christmas. She's usually too wiped out to hit the day after Christmas sales, but she does make sure to go as soon after as possible. She shops anywhere and everywhere all year round, but Dorothea's on Sutter Street is one of her local favorites.

Last, but not least - who can guess how many boxes will be needed to store these decorations: 50? 100? Nope, MORE. They need over 150 boxes, which are stored in the garage loft, attic and under beds. Each year, when Kathleen opens them all up, it feels like Christmas day to her. She has so many pieces that it's easy for her to forget exactly what is there during those endless nine months with no sign of Christmas.

Do the Christensens believe in Santa Claus? Yes, Virginia, they certainly do!
