These Debris Catchers capture the polishing media and other debris that falls from the drain holes in the bottom of Dillon Precision Casfeeders. Each Debris Catcher holds just over 1 Teaspoon of debris. The translucent window allows you to easily see the debris level in each catcher.



Although photo at left shows Casefeeder Bowl #13400, the instructions below are the same for Casefeeder Bowl #13400 VER. 2.

Installing Debris Catchers:

- 1. Clean surface of Casefeeder where the Debris Catchers will be attached using Rubbing Alcohol and then let dry.
- 2. Peel off the protective film on the Alien Tape™. Do not touch Alien Tape™ surface with your fingers.
- 3. Press Debris Catchers onto Casefeeder immediately below drain holes.

Emptying Debris Catchers:

Although each Debris Catcher easily holds 1 Tsp of debris, it is recommended to empty the Debris Catchers when they are about 1/2 full. This greatly reduces the possibility of spilling debris when detaching the Debris Catchers from the Casefeeder.

- 1. Gently twist Debris Catcher to release grip of the Alien Tape™. Do not pull straight off
- 2. Empty debris from Debris Catcher.
- 3. Reattach Debris Catchers to Casefeeder.

Cleaning Alien Tape:

If the Alien Tape™ does not want to reattach securely, clean the Alien Tape™ surface with plain water. Allow to dry thoroughly before reattaching to Casefeeder.

Do not use paper towels as this will contaminate the Alien Tape™ surface with paper residue.

Also clean surface of Casefeeder.
