Editing Package Work Order

The process of service will be:

• Work Order Placement:

Editing service is provided on a first come, first served basis. Upon receipt of this work order we will inform you of your "place in line." We will contact you when your work order is in third place.

• Deposit:

50% deposit is required before we start editing your document. For example, if 10 hours is the maximum, you must pay \$72.50. If you do not pay the deposit before your turn, this work order will be cancelled. We will inform you when it is your turn and send an invoice for the deposit which must be paid before we begin.

• Document Submission:

We will send you a Unilateral Non-Disclosure Agreement. Send us the executed agreement along with your document after you pay the deposit. Be sure the document name includes your customer number.

• Editing:

When it's your turn, we will begin editing your document according to the options you checked above up to the maximum hours. We will contact you if we have any questions.

• Invoice:

We will send you an invoice including a time sheet. The total amount due must be paid within ten (10) days.

 <u>Work Order Completed</u>: Work done to date will be sent to you within two (2) days after the invoice is paid.

<u>Cancellation</u>: You can cancel this work order at any time before we begin.

<u>Refunds</u>: Deposits are refundable if you cancel this work order before we begin.
