Outdoor Application Fee: \$60.00 per space if paying with cash or check

\$65.00 per space if paying by credit card, square, cash app, venmo, etc.

Indoor Hall Fee: 12 Spaces available, includes electricity, tables, chairs and locked at night.

\$70.00 per space if paying with cash or check

\$75.00 per space if paying by credit card, square, cash app, venmo, etc.

It is highly encouraged for vendors to participate all 3 days from open to 10pm. If you select being in the hall, I recommend coming the day before if you would like to drive inside the fair gates to set up your booth. Otherwise, you will have to cart it from the front entrance. If anyone is setting up on the 19th contact us so someone will be at the fairgrounds. Outdoor vendors are responsible for providing their own tables and chairs. The space will be 10'x10'. You must leave your space clean at the end of each day and throw trash in the trash cans or in the dumpster if there is excessive trash. Vendor application fees are non-refundable.

You will be required to carry or cart your items into the vendor area. There will be a designated parking area inside the main event infield for vendors. The vendor space includes 2 vendor wristbands per day per vendor space. All additional people will be required to buy a daily wristband to enter the gate. There will be a vendor check-in table at the entrance.
