to the 2026 East National Spotlight Sale in Brome, Quebec on Saturday Sept 05, 2026 at approximately 6:15 pm.

♣ The consignor hereby warrants ownership of the animal free and clear of any and all liens or encumbrances.

♣ The consignor may place a hold price on the consignment below which the goat will not be sold. The hold price cannot be raised once the animal is nominated. The consignor retains ownership if the bid does not reach the specified hold price.

♣ The consignor agrees to pay the exact consignment fee within seven days of notification of acceptance by the 2026 East National Spotlight Sale Committee as per the following formula: A consignment fee of \$40.00 is required for up to a \$500.00 hold price. A consignment fee of 10% of the hold price is required for a hold price, which exceeds \$500.00. The consignment fee is credited to the 2026 East National Spotlight Sale's 10% commission. If there is not a hold price the consignor will immediately upon receipt of payment send the consignment fee to Longears@yahoo.ca All 2026 East National Spotlight Sale consignment fees will total 10% of the selling price plus the \$25.00 nomination fee. The consignment fee is forfeited to 2026 East National Spotlight Sale if the consignment fails to sell or is withdrawn without the consent of the 2026 East National Spotlight Sale Committee. The nomination fee must accompany the nomination package.

♣ The starting bid for each consignment will be \$350. In the event that the animal does not receive a successful bid the animal will remain under ownership and responsibility of the consignor.

♣ The successful bidder will ensure the consignor is paid in full prior to taking possession of the animal. Payment will be by e-transfer or cash and will be directly to the consignor.

♣ Consignment must conform to CGS Breed Standards, have correct and legible tattoos, be free of physical defects, and be sound and healthy. Otherwise, the consignment will be returned to the consignor at the consignor's cost and the consignment fee forfeited to the 2026 East National Spotlight Sale Committee. Consignments are expected to be raised/managed on a CAE prevention control program.

♣ Consignments must arrive at the Sale location (at the consignor's expense) by Friday, Sept 4, 2026 by 4 PM; preferably earlier in the day. Each consignor shall provide, at his/her time of arrival, any updated

show or performance information since the time of nomination. The health certificate must show the animal to have been negative for the CAE testing within 40 days of the sale date.

♣ For the health of the consignment during and after the sale, the animal should have at least one inch or more of hair coat at the time of the sale. A full body clip, with a number 5 blade should occur no later than August 15, 2026. Absolutely no full body clipping is allowed after this date. Hooves are to be properly trimmed before arriving at the sale.

♣ The 2026 East National Spotlight Sale Committee will provide penning. Feed, bedding, water, care, etc. are the responsibility of the consignor until the animal has been purchased.

♣ The 2026 East National Spotlight Sale Committee provides top show people to present consignments at the sale, unless it is instructed, IN WRITING, that the consignor will provide one. This document must be presented at the time of the animal's arrival. As these animals are elite representations of the breed it is expected that the handlers will be in suitable attire which reflects the animal's quality.

♣ The 2026 East National Spotlight Sale Committee will ensure that the animal participates in the health check as per CGS standards upon arrival. The animal must pass the health check to participate in the sale. In the event that the animal fails the health check the consignor (at his/her expense) may have a veterinarian examine the animal to re-evaluate suitability for the sale.

♣ The 2026 East National Spotlight Sale provides reasonable safeguards for the health and safety of the consignments. However, responsibility of the animal and risk or loss, injury or death to the animal remains the consignor's until the consignment sells.

♣ Substitution of a nominee/consignment because of death, sickness, or injury may be approved after presentation of the facts to the 2026 East National Spotlight Sale Committee. The 2026 East National Spotlight Sale will not accept a substitute that it deems is of lesser quality than the original nominee.

♣ The consignor must immediately upon receipt of payment for the animal provide the buyer with a copy of a signed and completed CGS transfer and CGS registration certificate. As per the Canadian Livestock Pedigree Act it is the responsibility of the consignor to transfer ownership into the successful bidder's name.

♣ It is the responsibility of the 2026 East National Spotlight Sale Committee to determine the sale order. Lot number does not equal sale order. Sale order is released at approximately 10:00 am the day of the sale. The Committee shall decide how the sale order information is to be announced.

♣ Consignment's breeding activity, if any, both A.I. and natural service, must be disclosed in writing in full specific details, at the time of the animals arrival. It MUST be accompanied by a copy of the A.I. sire collection form and/or breeding certificate which will be provided immediately after payment is received for the animal. Bucks must be of virgin status. If a consigned buck is found to have been used the buck will not be allowed to go through the sale and the consignor will be held responsible for all costs related to the animal, including transportation, health certificates and other items relating to the animal as a consignment. The committee prefers that does be sold open (not bred) unless the breeding is agreed upon at the time of nomination. If a consignment is bred, she must be accompanied to the Sale with a complete service memo. THERE SHALL BE ABSOLUTELY NO COLLECTION OR BREEDING ACTIVITY AT THE SALE LOCATION.

♣ This contract becomes effective upon the acceptance of the nominee by the 2026 East National Spotlight Sale Committee.
