Photography & Videography

Under no conditions, are photos and/or videos to be taken at Competitions back stage or in the theatre as per 2025 Calisthenics Victoria ruling. This is a breach of privacy.

Coaches are approved to video in class for practice purposes for pupils, which is loaded on to our Club YouTube page, on a private link. This link is to remain private and accessible by the relevant J'adore section members only.

Be responsible for what you write

All Club Members need to take responsibility for what they write, and exercise good judgment and common sense when representing J'adore Calisthenics. Any photos or comments used in a discriminatory way is not acceptable and will be a breach of this policy.

Exercise good judgment

Refrain from comments that can be interpreted as slurs, demeaning, inflammatory, etc. Any photos published representing or involving J'adore Calisthenics which are seen in a provocative way is a breach of this agreement.

Respect privacy and copyrights

It is a breach of our Child Protection to take photos of Children without parents' consent. Please note that this also includes the publishing of this content. You must seek written permission from the parent/guardian before publishing any content of Team Members under the age of 18.

No photos or videos are to be shared of any J'adore performances as this is a breach of copyright. It is unacceptable to post or share any material to social media channels of any Class work or performance.

Bring value

We encourage you to be a part of our Social Media Pages and encourage you to bring positive value with any specific J'adore Calisthenics publications. Our best form of advertisement is through word of mouth, so we encourage you to 're-share' any posts directly from our Social Pages.

Social Media Group Chats

The Club does not endorse any section chats/forums that are not created by the Club Administrators or Head Coach. We ask members to refrain from creating these groups to discuss Calisthenics.
