

Meeting Minutes Franklinton Borough December 3, 2025

POLICE AND FIRE REPORTS: Distributed in packets. Brian Rodgers was present from Wellsville Fire Company. Reported on upcoming events and the Santa Engine scheduled for Dec 13th at the Franklinton Borough Office. Also mentioned the contract payment due of 9500 for 2025 contract was not received 12/2024 and the 2026 contract is due 12/2025.

PUBLIC COMMENT: Isabelle Harman is volunteering to look up grants from public foundations that help municipalities with infrastructure and possibly finding water. She also mentioned a program called Press Forward for media coverage for events- she is going to get more information on this and provide to council.

PREVIOUS MONTHS MINUTES. D. Bible made a motion to accept previous months minutes. D. Swab seconded the motion and it carried.

ENGINEER REPORT- P. BRATH – further agenda items.

SOLICITOR REPORT – D. DETHLEFS. No report.

PARK COMMITTEE – meeting minutes were distributed. D. Steidler reported DCNR Extension was approved 12/2026. Distributed flyers .25 per Franklinton Post office box. A question was asked if the budget was increased for the Archie Hess Memorial Park Project, the answer was not yet. Santa Engine event scheduled for December 13th.

K. Metzger made a motion to have the speed limit signs installed by Red UP LLC so long as it is under \$1000. D. Isenberg seconded the motion and it carried. M. Adams recused himself due to being related to the owner of Red Up LLC.

D. Bible made a motion to approve the first Wednesday of each month at 7PM to be the 2026 Council Meetings except for January 5th, Monday the Special Reorg meeting at 6:30 PM. D. Swab seconded the motion and it carried.

D. Bible made a motion to make the payment to Waggoner Construction Inc for \$9680, from Gen Fund so long as it's paid back from Parks and Rec when Funds are available. D. Steidler seconded the motion and it carried.

A discussion happened about raising the Parks and Rec Fee for New Construction to \$2200.00 with the Fee Resolution for 2026.

A discussion happened about the Trash Contract and whether or not to lower rates with the new contract. Looking at the cost of the contract, if the contract is kept the same, the rate could stay the same for three years for the residents.

D. Swab made a motion to adjourn the meeting; D. Steidler seconded the motion, and it carried.
