PREVIOUS MONTHS MINUTES. D. Bible made a motion to approve previous months minutes. D. Steidler seconded the motion, and the motion carried.

ENGINEER REPORT- P. BRATH – The Grant application was submitted for new signs for the Borough on 6/30/2025. We should know in September at the earliest, or November whether the grant was approved. Mac Mor is starting the grading project soon for the Archie Hess Memorial Park Improvement project. Discussion took place about the Park Project Budget and the need to communicate with DCED about the need for more funds than remains on the current grant.
