- (b) To maintain, repair, replace, approve, operate and manage such common and private areas and structures as may be placed under the jurisdiction of this corporation.
- (c) To promote the health, safety and welfare of the residents of the residential community to be known as Yacht Club Estates.
- (d) To enforce the provisions of the Declaration and By-Laws or Rules and Regulations consistent with such declarations now existing or hereafter adopted by whatever legal means are available under Kentucky Law.

2.2 The Corporation shall make no distributions of income to its members, directors or officers.

ARTICLE 3

Powers

- 3.2 The Corporation shall have all of the powers and duties set forth in KRS 273.161 KRS 273.400 and KRS 381.805 KRS 381.910 and as amended, all of the powers and duties reasonably necessary to operate the homeowners association pursuant to the Declaration of Covenants, Conditions and Restrictions and as it may be amended from time to time, including, but not limited to (unless such obligations, purposes, duties or rights are assumed by any governmental agency or instrumentality having jurisdiction thereof), the following:
- a. To fix, levy, collect and enforce payment by any lawful means, all charges or assessments and assessment liens by the Association pursuant to the terms of the Declarations; to pay all expenses incident to the conduct of the business of this corporation, including all licenses, taxes or governmental charges levied or imposed against the property of this corporation.
- b. To use the proceeds of assessments in the exercise of its other powers and duties.
- c. The regular and special construction, maintenance, repair, inspection and protection of the streets, as shown on the plats of Yacht Club Estates or otherwise, and the acceptance of all common areas for the purposes of operation, maintenance, supervision and repair.
- d. To make and amend reasonable regulations respecting the use of the property in the Condominium Regime; provided, however, that all such regulations and their amendments shall be approved by not less than 51% of the votes of the entire membership present of the Corporation before such shall become effective, and only insofar as such powers of enforcement are conferred and not in conflict with the Master Deed Declaration of Condominium Horizontal Property Regime of Yacht Club Estates.

Every person or entity who is a record owner of a fee simple or of a fractional undivided fee simple interest in any Condominium Unit is subject, by covenants of record, to the jurisdiction and powers of this corporation, and particularly to the assessment and assessment lien powers of this corporation, shall be a member of this corporation and only such persons or entities shall qualify for membership or continuation of membership. The foregoing is not intended to include persons or entities who hold an interest merely as security for the performance of an obligation. As used in these Articles of Incorporation, the term "Condominium Unit" means and refers only to condominium units are or may become subject to the appurtenant to and may not be separated from ownership shall be appurtenant to and may not be separated from ownership of any lot.
