

**FIRST AMENDMENT TO THE MASTER DEED AND DECLARATION OF CONDOMINIUM PROPERTY
REGIME OF COLLEGE COURT CONDOMINIUMS**

This First Amendment ("Amendment") to the Master Deed and Declaration of Condominium Property Regime of College Court Condominiums ("Master Deed") is made at the direction of the College Court Resident Council, Inc, by and through its court appointed Receiver, as an amendment to that Master Deed, dated the 12th day of November 1987 and filed of record in **Deed Book 5727, Page 494** in the Office of the Clerk of Jefferson County, Kentucky:

WITNESSETH

WHEREAS, College Court Resident Council, Inc, by and through its court appointed Receiver, believes the Master Deed, needs to be amended and this Amendment is necessary and desirable;

WHEREAS, the non-profit, non-stock corporation association for the College Court Condominiums, the College Court Resident Council, Inc., is in a receivership pursuant to those orders issued in *EuroTech, Inc. v. College Court Resident Council, Inc., et al.*, 13-CI-01046 (Jefferson, Ky. Circuit Court Division 1);

WHEREAS, a motion was made in the above-referenced civil action to authorize the Receiver to prepare and file this Amendment;

NOW, THEREFORE, in accordance with the foregoing preambles, which are hereby incorporated herein, College Court Resident Council, Inc. and the College Court Condominiums hereby declares that the aforementioned Master Deed is hereby amended as follows and that all such property shall be owned, held, used, leased, conveyed, and occupied subject to the restrictions and conditions set forth in this Amendment as if these restrictions and conditions were included in and made a part of the Master Deed, such that Paragraph Q-1 of the Master Deed is stricken in its

entirety and replaced as follows:

1. **Amendment of Declaration.** This Declaration may be amended by an affirmative vote or agreement of unit owners of units to which at least 60% of the votes in the association are allocated at an annual meeting or at a duly called special meeting of the Association.

IN WITNESS WHEREOF, the College Court Resident Council, Inc., by and through its Receiver,, has caused this Amendment to the Master Deed and Declaration of Condominium Property Regime of College Court Condominiums to be executed this 31st day of August 2015.
