MOTION: Moved by Meagher and seconded by Nelson to approve a Service Connected Disability Pension application for Mr. Cardinale effective at August 13, 2025, which provides that benefits are calculated at 2 ½% of the member's average 60 month compensation for the first twelve years of service and all years of service until the member has reached 50 years of age; and 3 1/3% of his average 60 month pensionable compensation for all years of service and any portion of a year beyond 12 years of service

and 50 years of age; If the member has 30 years or more of service the retirement benefit for each year or portion of a year shall be 3 1/3% of the average 60 month pensionable compensation up to 100% of pensionable salary.

#### Pensioners:

<u>Charles Ledet</u> died on July 12, 2025 at the age of 81, leaving a widow and no minor children. He entered the department on October 14, 1967 and retired on September 17, 1988 with 21 years of service. He spent 36 years on pension.

<u>Joseph Wilder</u> died on July 14, 2025 at the age of 83, leaving a widow and no minor children. He entered the department on March 3, 1963 and retired on august 17, 1987, with 24 years of service. He spent 37 years on pension.

<u>Review of Statute 11:3378(g)</u> Staff is requesting that the Board's legal counsel confirm that disability payments to dependent children are not provided to children of retired members.
