For those of you watering lawns please water at night or in the morning when it is cool. This will help to conserve water.

Business

New Reserve Study discussion. Jeremy has been contacting companies to get quotes for performing a reserve study. Only one responded and it was the company that did the PPPOA reserve study. They gave a couple of options. Option 1 was a just do the reserve study alone for \$4950. Option 3 was to do the reserve study and then update it in years 2 and 3 for a cost of \$725 per year. The company said they anticipated the life of PVC to be 50-60 years versus the Engineers who did the Master Plan who anticipate the life span of PVC to be 100 years. Discussion ensued about trying to gather some more quotes from companies to perform a reserve study. Jeremy will try to get another bid at least.

Water usage billing from previous meeting. Mary proposed an idea to have a committee of community members to look at updated member billing. ussion. Jeremy is going to ask Bill if he had any insight to fire hydrant locations.
