New Business

- Motion was made to accept the 2024 PPWC Expense Budget by Cheryl Riddle, 2nd by Vincent Lorraine. Passed unanimously.
- Discussion of Annual Billing Letter. Agreement made that verbiage will state that PPWC and PPPOA will continue to be separate entities.
- Update of bank signers.
 - Motion of 08-29-23 to add Vincent Lorraine and to remove Steve Maurer was rescinded.
 - O Jeff Harris made a Motion to remove Robert S. Maurer Jr. as a signer on the following PPWC bank accounts: Mid Oregon Credit Union Money Market Reserve account, USBank Money Market Reserve account and the WaFd Bank Money Market Reserve account, and the WaFed Checking account. Jeffrey Harris, President, Cheryl M. Riddle, Treasurer, Tina Kemp, Director, and Kent Dollarhyde, Director, will remain as signers on all the PPWC Bank Accounts. 2nd by Cheryl Riddle and passed unanimously.
- Discussion of backup generator propane tank replacement and change of propane supplier to Ed Staub.
 - Quote received from Ed Staub and with lower propane pricing it makes long term cost sense to replace the tank.
 - o Price to replace the tank is approximately \$3700.
 - O After discussion, funding for the replacement will come from the reserve fund.

- Jeff Harris made a motion to replace the propane tank for the backup generator for a price of \$3700, including purchase and installation from Ed Staub. 2nd by Vincent Lorraine. Passed unanimously.
- Discussion of PPWC Master Plan Update
 - o Jeff has not heard much feedback to the study. Several board members plan on submitting feedback to Jeff in a timely manner.

Concerns of the Board

- David Trachsel brought up that the Deschutes County property tax bill for PPWC came to the PPPOA mail address. Cheryl Riddle stated that she will have the address changed.
- Jeff had a concern that given the recent ups and downs of the board, that board members please communicate directly when possible and try to avoid heated email exchanges and to try and minimize any drama.

Concerns of the Members

• Desera Nelson messaged that according to the PPWC reserve study, the PPWC will not have \$15,000.00 for a master plan-update until 2025. Jeff stated that it would be unlikely that the master plan will be updated until 2025.
