From West LIE (I-495): To Exit 56, Rt. 111. Left on Rt. 111, North 4 miles, stay in center lane, continue across Rt. 25 (Jericho Tpk.). Bear right onto Rt. 25A East (North Country Road). 4 miles to show entrance on right.

From East LIE (I-495): To Exit 62, Rt. 97 (Nicholls Rd.), North @ 10 miles to Rt. 25A, left at light onto Rt. 25A. Continue @ 2 miles to show entrance on left. **Hotels in the area:**
