MEMBERSHIP TERMS AND CONDITIONS

1. These terms and conditions (Terms) set out the rules governing The Green Pinnacle membership and membership payments online.
2. By signing this application I agree to abide by the Rules set out by The Green Pinnacle management.
3. I have also read and agree to the general terms and conditions at The Green Pinnacle.

1. ENROLLMENT

- a. by filling out and signing this form, you agree to enroll in our membership subscription, and become a 'member' of the Green Pinnacle.
- b. by enrolling as a 'member' you enter into a binding agreement to receive the above services, annually, subject to these terms and conditions.
- c. your membership subscription is for use by the named signatory only, this membership is non transferrable. In the case of a family membership, the benefits are applicable to immediate relatives, living under the same address.

2. FEES

- a. You agree to pay a membership subscription fee.
- b. if paying by bank transfer, you agree to pay the amount invoiced, before the due date.
- c. If paying by debit/credit card, fees will be charged and billed to your nominated debit/credit card.
- d. If paying by EFTPOS/cash, you agree to pay the full amount, prior to your membership beginning.
- e. There may be additional fees for payment processing, you agree to pay these processing fees.

3. LATE PAYMENTS

- a. If payment is not successfully processed (e.g., due to expired or insufficient funds), you may lose access to membership benefits until the payment is resolved.

4. BENEFITS AND CONDITIONS

- a. At the end of your subscription period, membership renews automatically unless you resign, in writing, prior to the expiry date.
  - i. An invoice will be created at the beginning of your membership period.

5. LIABILITY

- a. You have rights under the Consumer Guarantees Act 1993 and the Fair Trading Act 1986. Other than those rights and the rights given to you under this contract: we will not be liable to you for any direct, indirect or consequential loss or damage or injury of any kind to you or your property, however it arises.
- b. We will not be obliged to give you any refund of fees paid for your membership if you fail to use your membership or terminate early, before the end of your subscription period.

6. TERMINATION

- a. You are able to resign from your membership subscription in writing by email to [info@thegreenpinnacle.co.nz](mailto:info@thegreenpinnacle.co.nz) no less than 30 days before your subscription expiry date. Failure to follow this term renders you liable for the current membership subscription and its associated fees.
- b. At any time, we can terminate your membership subscription immediately by giving you notice in writing or by email if we reasonably believe you have seriously breached an important term of this contract, including:
  - i. breaching any rules such as carrying out any illegal, offensive, or unsafe activity on the premises.
  - ii. If we do terminate your membership under this clause because of your serious breach of this contract, we are still entitled to recover our costs and losses under this contract.

7. CATEGORY CHANGES

- a. You may wish to change your membership subscription category. Outside of extreme circumstances, your category can only be changed during the renewal of your subscription. To change your membership subscription category outside of the renewal period, you will need to contact The Green Pinnacle management.
- b. Putting your membership on hold
  - i. You may wish to put your membership on hold, for a range of reasons. You may 'hold' your membership for up to 365 days, this will temporarily stop all of your membership subscription benefits and payments, until you choose to continue your membership. The fee for putting your membership on 'hold' is a one time payment of \$200.00. Your membership will not be considered as on hold until the payment of the one time fee.
  - ii. After continuing your membership, the membership subscription cannot be put on hold until the expiry date of your current membership.

8. Restrictions and allowances

- a. Your membership may be entitled to bay hire with no cost, there are limits regarding the applicable times and who may claim this benefit. Your included bay hire is subject to the following terms:
  - i. Bay hire may only be claimed when the booking is for a member, and that member with the appropriate privileges is present
    1. In the case of a family membership, a nominated family member must be present
  - ii. Practice members are not permitted to bring guests during their booking
  - iii. Bay hire entitlements are subject to off peak, on peak, and practice times.
    1. Individual and family members are permitted to take advantage of their included bay hire during off peak and practice times only
    2. Practice members are permitted to take advantage of their included bay hire during practice times only
    3. The Green Pinnacle will indicate what times are considered off peak, on peak, and practice. These stipulated times can change at any time.
- b. Your benefits are applicable to one booking per day.
  - i. Any additional bookings are subject to standard pricing.

9. CHANGES TO THESE TERMS

- a. The Green Pinnacle may change any of these Terms at any time.
- b. You are responsible for checking the Terms regularly to review any such changes.
- c. Continued usage of The Green Pinnacle membership subscription following the publication of any changes to the Terms confirms your acceptance of those changes.
