IGR Report given by Patty Z

Patty attended the Assembly in December and Unity Committee spoke about cost of translators for conventions being held in multiple languages. The need to explore other, more affordable resources, for translators for all of AA's conventions as this is needed but also costly. They are searching for more affordable means to provide this service.

Patty will continue to update as she receives information.

Old Business: Discussion of the new Trust Servants position voted on in November and passed unanimously, to have a greeter at our meetings. After discussion about the persons needed to perform these duties, the following was shared:

- Having a simple script for one person (the Greeter) to welcome people as they come in. Greeters will come on at 6:45am with Chairperson, to greet at 7:55am. Host will mute all, and allow greeter to perform their service.

Patty submitted the following script for the Greeter after Nov Bus Meeting:

We suggest you log on to our Sunshine group meeting, ten minutes before the meeting begins, 6:50am.

When someone joins the meeting you might say, **“Hello, my name is _____, welcome to our meeting. If you are new or this is your first time here with us, Welcome.”**

- We suggest that you log into our Sunshine7am meeting fifteen minutes before the meeting begins at 6:45am.
- If there is no Greeter designated for a meeting, **only** the Chairperson will greet those coming in to attend the meeting. (to keep it simple)
- The Host will mute the room and the greeter will welcome attendees until the meeting begins at 7am.
- 90 days of sobriety is suggested to do service as a Greeter and anyone interested can volunteer for this position. (This position’s part can be tweaked as we learn how it works).

The following was suggested:

For Abiel to please place in Secretary’s Report at this bus meeting.

- **“Are you interested in volunteering to serve as a chair, host or as Greeter at this meeting? You only need six months of sobriety to chair/host and three months to greet. Supportive training is available. Ask any member for more information.**
- **Also, to amend report to read the “raise your hand” from the Reaction button at bottom of page.**
- Marye S is our greeter for Saturday meetings beginning 1/24/26, and will greet throughout February 2026. Suzanne will send her the script.
- When reading the Secretary’s Report (if info not in report yet) Chairperson can announce this position and invite those interested to the next Bus Meeting.

New Business –

Gillie (and a couple of others over the past month or so) brought up concern about the Sunshine7am meeting coming up as Abiel’s Personal Meeting Room on the Zoom platform we are using. A vote taken to ask Abiel to place the meeting under its original name of Sunshine7am Meeting Room.

Julie will call Abiel to discuss going back to our original name.
