With more than \$403,000 made available through its endowed funds this year, 2020 is providing the Foundation's highest payout ever. While our offices are closed and we are working from home, issuance of payout checks may be postponed. Apply at occf-in.communityforce.com. Deadline is April 10, 2020 at 4:00 PM.


