4. The objects for which the corporation is incorporated are:  
Objets pour lesquels la personne morale est constituée:
- i) The Tewaaraton Lacrosse League's (TLL) Purpose/Mandate is to continue to grow lacrosse, celebrating the game's rich heritage, and provide an equal opportunity league lacrosse players.
  - ii) The TLL is high-performance amateur league for lacrosse players twenty-two younger (22U).
  - iii) The league is built on the pillars of collaboration, education, and inclusion.

5. The special provisions are:  
Dispositions particulières:

The corporation shall be carried on without the purpose of gain for its members, and any profits or other accretions to the corporation shall be used in promoting its objects.

i) All Founding Members and Active Members that are deemed Members in Good Standing have the right to appoint one (1) Voting Member to the Board of the TLL. Each Director/Governor shall carry one (1) vote at any meeting convened by the TLL Board on behalf of the Voting Member.

ii) The membership of the TLL shall be determined by the Board of Directors/Governors and shall be limited to those lacrosse clubs who are interested in the Purpose/Mandate of the TLL.

iii) The Board of Directors/Governors shall be comprised of a minimum of three (3) individuals and a maximum of twenty (20).


iv) There shall be at least one (1) general meeting per year of all Voting Members of the TLL. The following business shall be conducted at the annual general meeting:

- a. The presentation of the financial statements;
- b. Ratify the appointed Directors/Governors,
- c. The election of the Executive;
- d. The appointment of the President; and
- e. The appointment of the Accountant.

v) The Directors/Governors terms shall be one (1) year, commencing at the annual general meeting of the Voting Members which they are appointed, and shall hold office until their successors have been appointed in accordance with this Constitution, unless they resign, are removed, or vacate their office.

vi) The Executive positions must be filled by Members in Good Standing and the President position must be filled from a Founding Member lacrosse club representative. The Founding Member whose Voting Member appointment has been elected President, shall appoint one (1) additional Voting Member to the Board of Directors/Governors of the TLL to represent that Founding Member's votes at any meeting convened by the TLL Board.

vii) In the event of liquidation, dissolution or winding-up of TLL, all its remaining assets after payment of its liabilities shall be distributed to one or more charitable or not-for-profit organizations which carry on similar activities to those of TLL or whom have a similar purpose/mandate to the TLL, as determined by the Board.
