Const. Art. II, Sec. II, paragraph III); I will not knowingly violate any provisions of the Georgia Election Code (O.C.G.A. § 21-2) or of the rules or regulations adopted thereunder.

I understand that any false statement knowingly made by me in this Notice of Candidacy and Affidavit will subject me to criminal penalties as provided by law and I hereby request you to cause my name to be placed on the ballots to be used in such election as a candidate for the office I am seeking.

RE: Fingerprinting of Prospective Candidates for Office of Sheriff

ORDER

Official Code of Georgia Annotated 15-16-1(c)(1)(G) requires a fingerprint check and background search to be made of each prospective candidate for Sheriff under the direction of the Probate Judge. Such fingerprints are to be taken prior to close of the third business day after the qualification period for Sheriff. **Such period shall begin upon the court's signature and shall run during normal business hours until March 13, 2024**

The fingerprints shall be submitted under the **Fulton County Probate Court ORI Number: GA 060073J using purpose code "Z" for "O.C.G.A. 15-16-1-Candidate for Sheriff."**

The capturing of the fingerprints for persons qualifying to run for Sheriff shall be conducted by qualified personnel at the Fulton County Police Department, who will take the fingerprints by livescan and run the criminal background checks which will be sealed and returned to the Probate Court Judge immediately upon receipt of same.

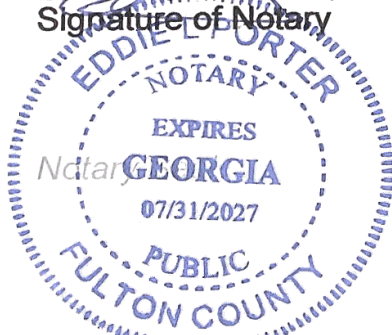


