### CLASS DESCRIPTIONS

#### DERBY DAY CLASSES

All derby day classes are open to juniors, amateurs and professionals.

Dressage Tests: Tests from USEA 2014 official tests.

Derby Classes: To consist of stadium and natural obstacles, occurring both in and out of the arena. Natural obstacles may consist of but not limited to: logs, banks, ditches, water and fixed obstacles. No liverpools in classes of heights lower than 3'. Scoring: Closest to optimum time without going over. Riders may elect to return for additional "schooling" rounds at their schooling height at \$30 per round.

This round is strictly for schooling. Only first rounds will be scored.

Heights and spreads:

2' - Not to exceed 2' height and 2' spread

2'6 - Not to exceed 2'6 in height and 2'9 in spread

3' - Not to exceed 3' in height and 3'3 in spread

3'3 - Not to exceed 3'3 in height and 3'6 in spread

3'6 - Not to exceed 3'6 in height and 3'9 in spread

3'9 - Not to exceed 3'9 in height and 4' in spread

Combined Derby Classes: The combined class consist of a dressage test and a derby round at each respective level.

Jumper Classes: Open to junior, amateurs and professionals. All classes have a \$5 add back prize to 1st place. Scored under Table II Section 2b.

**\$200 1.0m Jumper Stake & \$200 1.10m Jumper Classic** - Table II.2a/b. Riders with clean rounds may elect to jump off immediately or at the end of the class. Class must have a minimum of 5 entries to be held as \$200 class or class becomes a \$50 add back class with money paid to first. Riders must have shown in at least one jumper class prior to the Classic.

Prize monies 1st - \$100, 2nd - \$50, 3rd - \$35, 4th - \$15

## General Information, Rules & Regulations

### Conditions of Competition

Every class offered herein which is covered by the rules and specifications of the current USEF Rule Book will be conducted and judged in accordance therewith.

### El Sueño Entry Agreement

**By entering the Riverview Pony Club Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Rider or Handler and on behalf of myself and my principles, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of Riverview Pony Club, El Sueño Equestrian, The United States Equestrian Federation "USEF" and the local rules of the competition. I agree to be bound by the Bylaws and Rules of the USEF and of the competition. I will accept as the final decision of the Competition**

**Management on any questions arising under the Rules, and agree to release and hold harmless the competition, the USEF, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and /or participate under the rules, and every horse I am entering is eligible as entered. I also agree that as a condition of acceptance of entry, the competition may use or assign photographs, video, audios, cablecasts, or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition or the sport. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocable waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity. or to misappropriation.**

The Horse Show Management reserves the right to itself to interpret all questions and conditions in regards to or arising out of, or incident to the show without claims for damages or recourse of any kind. All questions not covered in these Rules and Regulations shall be decided by the Horse Show Management; its decision to be final.

The Horse Show Management reserves to itself the right to limit entries in any class, section or division, to refuse, accept conditionally, or to cancel any entries, disqualify any riders or exhibitors, prohibit exhibitions of entries, and cancel award prizes, without claim for damages; to change any course, to add a dotted line, to cancel or combine any unfilled classes, or to reschedule classes, after due notice to exhibitors; to change rings or rotate judges; to change specifications in Jumper classes as competition warrants.

Every horse entered herein for competition will be under the control of the Horse Show Management, but the Show Management will in no case be responsible for any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall hold the horse show and the officials, employees, directors, officers, sponsoring entities of the horse show and the facilities at which the horse show is held blameless for any loss or accident to his/her horse(s), employee(s), or equipment with may occur from sickness, fire or other cause.

#### **SAFETY:**

**Protective Headgear:** It is compulsory for riders in all Hunter, Jumper, Derby and Hunt Seat Equitation classes where jumping is required and when jumping anywhere on the competition grounds to wear properly fastened protective headgear that meets or exceeds ASTM standards for equestrian use and carries the SEI tag. It must be properly fitted and harness secured. The Show Management, committee and officials are not responsible for checking headgear worn for such compliance.

**Dogs must be restrained on the show grounds:** All dogs must be on a leash and under control at all times. Loose dogs will be picked up and detained and the owner fined \$100. Please be sure to pick up after your dog.

#### **El Sueño Equestrian Rules & Regulations**

1. No smoking in the barns, stalls, paddocks, corrals, near the shavings bins, manure pile or anywhere else there is combustible material.
2. Motorized vehicles including motorcycles, bicycles, skate boards, etc., are not allowed within the facilities.
3. Please deposit trash in the designated trash barrels.
4. Do not ride or graze horses on the landscaped areas.
5. Riders, trainers, grooms and spectators must be respectful to the boarders on property and stay within designated show areas.
6. Please use designated show restrooms and not restrooms in the barn.
7. All exhibitors, trainers and guests are expected to exhibit proper sportsmanship.
8. All participants must sign a Hold Harmless Agreement.
9. Riverview Pony Club reserves the right to limit or revoke participation at any time to anyone. Riders/horses deemed unsafe must dismount and leave the ring.
10. Exhibitors are to compete at their own risk.
11. While on show grounds riders must wear protective head gear at all times while mounted.
12. CHILDREN must be under adult supervision at all times. Unattended children will be put to work cleaning stalls in the barn.

GENERAL ACTIVITY RELEASE, ASSUMPTION OF RISK, WAIVER OF LIABILITY, AND INDEMNITY AGREEMENT

**FOR USPC NON-MEMBERS**

This document waives important legal rights. Read it carefully before signing.

I AGREE for myself, and/or my child, my/our administrators and assigns, in consideration for my, and/or my child's, participation in this United States Pony Clubs, Inc. (USPC) activity to the following:

I AGREE that I choose to participate voluntarily in an USPC activity, as a rider, driver, handler, lessee, owner, agent, spectator, volunteer, and/or trainer. I am fully aware and acknowledge that horse sports and USPC activities involve inherent dangerous risks of accident, loss, and serious bodily injury including, but not limited to, broken bones, head injuries, trauma, pain, suffering or death ("Harm"). I fully understand that this release covers, but is not limited to, inherent risks of an equine activity which mean a danger or condition that is an integral part of an equine activity, including but not limited to, any of the following: The propensity of an equine to behave in ways that may result in injury, death, or loss to persons on or around the equine; The unpredictability of an equine's reaction to sounds, sudden movement, unfamiliar objects, persons, or other animals; Hazards, including, but not limited to, surface or subsurface conditions; A collision with another equine, another animal, a person, or an object; The potential of an equine activity participant to act in a negligent manner that may contribute to injury, death, or loss to the person of the participant or to other persons, including but not limited to, failing to maintain control over an equine or failing to act within the ability of the participant.

I AGREE to release the USPC, its successors or assigns, officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations from all claims including, but not limited to, claims for money or property, disability, covenants, actions, suits, causes or action, obligations, debts, costs, expenses, attorneys' fees, judgments, orders and liabilities of whatsoever kind or nature in law, equity or otherwise, whether now known or unknown, suspected or unsuspected, and whether concealed or hidden, including but not limited to any state or federal statutory or common law claim or remedy of any kind whatsoever arising out of or in any way connected with any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the USPC or the USPC activity.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the USPC or the USPC activity, and specifically agree to the applicable state statute/law regarding equine/farm animal activity liability and signed posting (if any), in any state in which I or my child participates in a USPC activity. A true copy for all state statutes in effect at the time of the execution of this agreement is attached hereto and incorporated herein by reference as if set out fully in the text of this document.

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the USPC, the USPC activity, and the Ventura County Fairgrounds and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse in the USPC activity.

I AGREE that neither I, nor any one claiming through me, will hereafter bring, commence, prosecute or maintain, or cause or permit to be brought, commenced, prosecuted or maintained, any suit or action, either at law or in equity, in any court in the United States or in any state thereof, or elsewhere, against the USPC, the El Sueno Equestrian Center, their successors or assigns, for, on account of, arising out of, or in any way connected with any Harm to me or my horse, and that neither I, nor any one claiming through me, will enforce, prosecute, or recover upon, or attempt to enforce, prosecute, or recover upon, any claim or right of action whatsoever, which I, or any one claiming through me, may now have or hereafter assert, in any way connected with claims for Harm to me or my horse, and for claims made by others for any Harms caused by me or my horse at the USPC activity.

I AGREE this Agreement is the entire agreement of the parties, and supersedes all prior oral and written understandings and agreements. This Agreement may be modified only by a written amendment signed by both parties.

I AGREE that if any provision of the Agreement is found to be invalid or illegal by a court of competent jurisdiction, the remaining provisions shall be construed as if the affected provision had not been included in order to effectuate the intent of the parties.

In the event this form is signed by the parent/guardian of a child, then all representations and acknowledgements herein are expressly made by, for, and on behalf of the parent/guardian and child.

By signing below, I AGREE to be bound by all applicable USPC rules and all terms and provisions of the USPC activity. I acknowledge that I enter into this release after having read the same, and place my signature hereto of my own free voluntary act and deed. By signing below, I represent to the USPC that I fully understand its contents, that I do not need any further explanation, and I waive any further explanation.

I HEREBY EXPRESSLY, VOLUNTARILY, AND UNCONDITIONALLY RELEASE, INDEMNIFY AND HOLD HARMLESS El Sueño Equestrian Center, Lisa Ciesniewski and/or Dark Horse Farms, their owners, officers, members, agents, employees, licensees and invitees, as well as any other person, firm, corporation, company, entity, or anyone in any way connected with the ownership and management of the show premises and the Horse Show, or in control of the premises or equipment related thereto (collectively, "Releasees") from and against ANY AND ALL CLAIMS FOR INJURIES, DAMAGES, AND/OR LOSES connected with participation in the Horse Show. This includes, but is not limited to, claims for monetary damages, attorney's fees, costs, losses, and/or causes of action against Releasees for any and all HARM to me or my horse(s) and for any HARM caused or contributed in any way to by me or my horse(s) to others, arising out of or in any way connected with participation in the Horse Show, and includes reimbursement of Releasees' costs and attorney's fees incurred in defense of such claims. I further agree to this release, indemnification, and holding harmless WHETHER OR NOT SUCH CLAIM, INJURY, DAMAGE, OR LOSS RESULTED, DIRECTLY OR INDIRECTLY, FROM MY NEGLIGENT ACTS OR OMISSIONS OF THE NEGLIGENT ACTS OR OMISSIONS OF RELEASEES, to the fullest extent allowed by law. I also acknowledge that no representations or warranties, whether oral or written, implied or expressed, have been made by Releasees concerning the Horse Show premises, the Horse Show Event, or the activities at El Sueño Equestrian Center and/or Dark Horse Farms, or any other matter.
