Information You Provide to TWGF

Registration Information. If you fill-out/complete any document on our website, or if you elect to donate monies to **TWGF** by filling-out/completing any documents obtained through links on our website, or if you sign up for emails or other updates from **TWGF**, our dedicated non-profit 'Ohana may ask you for basic contact information, to include name(s) email address(es), phone number(s) and/or USPS mailing address(es). **TWGF** may also collect certain demographic information from you, to include age(s), gender, personal interests, income, donation tolerance and marital status.

Communication. If you contact **TWGF** directly, our non-profit 'Ohana may again collect the same type(s) of personal information from you which was previously/already requested by **TWGF** on one or more of the forms you already filled-out/completed. For example, **TWGF** may again ask for name(s), email address(es), USPS mailing address(es), phone number(s), and/or other related & relevant personal contact information. **TWGF** may also elect at its sole & separate discretion to store the content(s) of any message(s) or attachment(s) that you send to **TWGF** by email and/or by any other like type(s) of communication, as well as likely store & retain any information you submit to **TWGF** through any of our forms or questionnaires or applications or donation sites/links.

Events. If you inquire about and/or attend an event that **TWGF** plans or stages or hosts, whether in-person or on-line, **TWGF** may collect personal information it deems relevant or necessary or helpful, to include name(s), address(es), employment status & job title(s), donation tolerance(s), phone number(s) or email address(es), as well as specific information relevant to the referenced event.

User Content. **TWGF** may allow you and other users of/visitors to our **TWGF** website and/or to our related donation links & sites to share content with **TWGF**/others. This content may include posts, comments, reviews, or other user-generated / visitor-generated content. Unless otherwise noted when creating such content, this information may be shared publicly through services & platforms offered and/or used by **TWGF**.
