None.

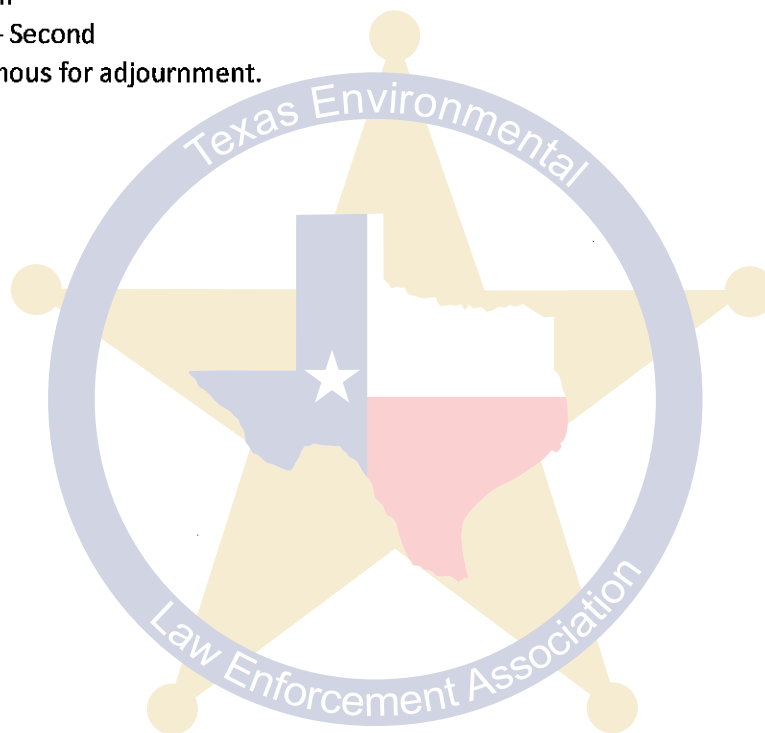

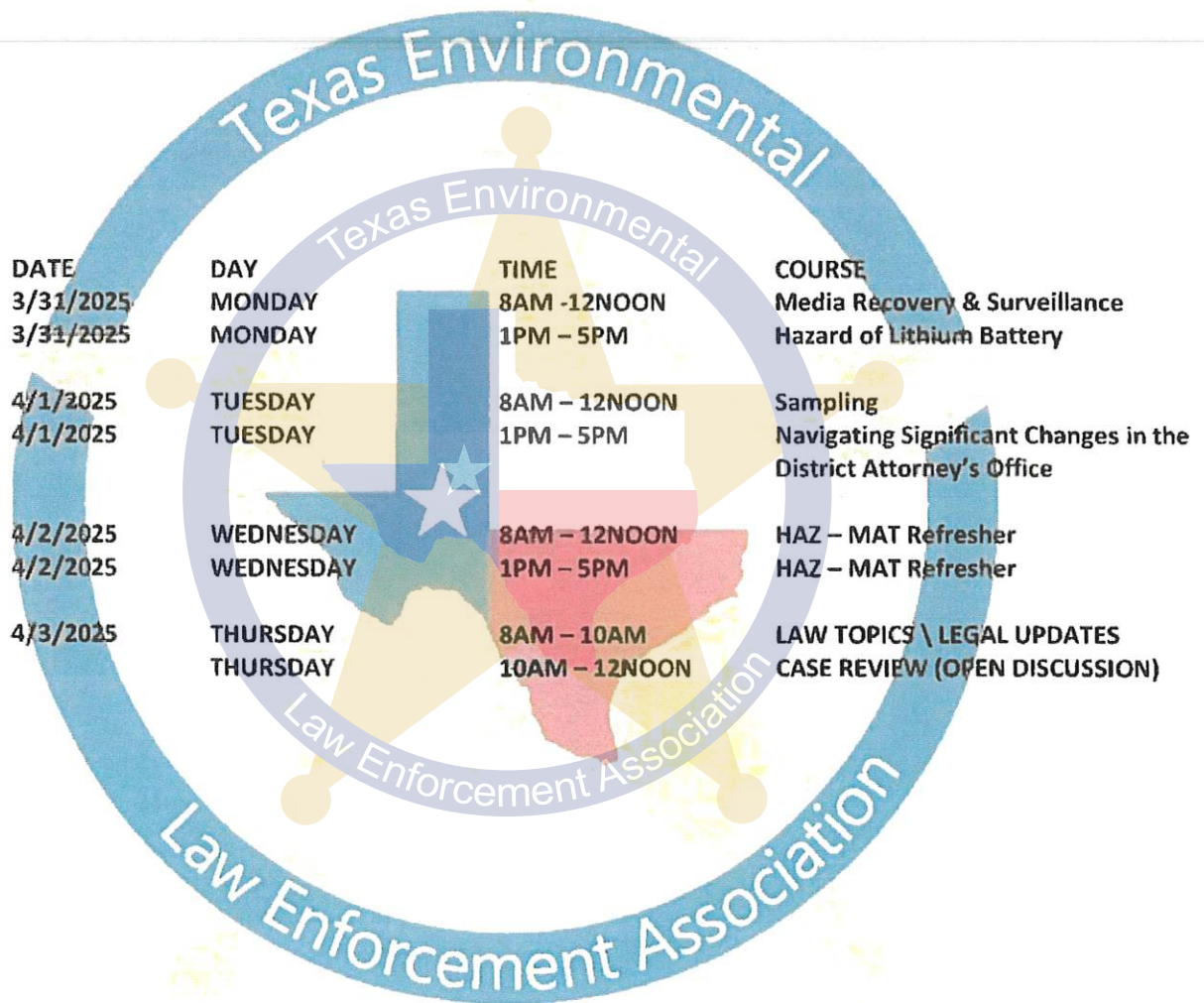
