## **Review 12-105 Suit and overview of settlement**

Our attorney decided with their attorney not to pursue prior to Jim's deposition. Jim said he had no input on the decision, but was the one with knowledge of the entire matter and was not deposed. Sandra and David are pursuing an Inquiry with the FL Bar Association. Our costs are approx. \$10k for their attorney, \$25-30k for our attorney, plus expenses to fix.

**Re: 12-306** This matter was rejected by the deceased/owner insurance and they are seeking \$59,000 repayment of demo costs. J&L provided the photos showing the horrid condition of the unit prior to being cleaned out for the owners/heirs to review. Board is waiting response.

**40 yr Inspection** - Roof issues (elec boxes, wires, etc) have been sent to homeowners and all responded except three. They will have 30 days for re inspection. Pastor repaired wires to unit. The GFI, Smoke detectors, Stairway Lights- are on hold for more information, as per board.

**BOARD OF GOVERNORS REPORT:** No meeting in July, nothing to report.

#### **OLD BUSINESS:**

**Pool Roof-** Deposit was paid, still waiting permit. Jim was told it was submitted by Roofing Contractor July 6 -need to follow up on the status.

**40yr Inspection Progress-** stated in management report.
