Here are some tax updates for you:

- The One Big Beautiful Bill Act changed a lot for us this year. See the attached cheat sheet for a quick reference of changes in 2025 and 2026. If you think something could affect you don't be afraid to ask us.
- The standard deductions for 2025 are \$31,500 married filing joint, \$23,625 head of household, and \$15,750 single. You may be able to itemize for 2025 due to some of the law changes. See the attached list of changes.
- If you claim mileage for a business the mileage rate for 2025 is .70 cents per mile.

## **EFFECTIVE 2025**

- 1- Interest deduction for cars purchased in 2025. Up to \$10,000 even if you don't itemize. Need VIN to claim on taxes. Vehicle is for personal use and final assembly occurred in the United States.
- 2- Temporary senior deduction MFJ-Over 65. Up to \$6,000 each with phase outs \$75k + \$150k
- 3- Enhancement of adoption tax credit, more refundable
- 4- Extension and enhancement of increased standard deduction  
This is about not going back to standard deduction plus exemptions from before 2008.
- 5- SALT increased to \$40,000 this means more property taxes and local income tax paid could help you itemize in 2025. This was limited to \$10,000 previously
- 6- No tax on tips, must file MFJ if married  
Deduction up to \$25,000 of tips received.
- 7- No tax on overtime  
Deduct 12,5000 if filing single or 25,000 for joint filers
- 8- Affordable Care Act CAP is terminated, pay back could be more  
For taxpayers on Affordable care act insurance.

## **EFFECTIVE 2026**

- 1- Partial deduction for charitable deduction. MFJ-\$2,000.00  
Single-\$1,000.00, available without itemizing
- 2- Enhancement of child tax credit. 35% to 50% of qualifying expenses
- 3- Extension and enhancement of increased child tax credit
- 4- Termination of energy efficient home improvement credit
- 5- termination of residential clean energy credit.
- 6- Termination of misc itemized deductions except for educator expenses.
- 7- Extension and modification of limitation on deduction and exclusion of moving expenses.
- 8- Limitation of wagering losses
- 9- Limitation of some charitable contributions
