Dear Valued Client,

As we prepare to ring in the new year, Tax Pros Seneca hopes that 2022 was a happy and healthy year for you. We are honored to have you as a client, and as always, are dedicated to providing you with up-to-the-minute tax knowledge to ensure you the most accurate return available anywhere. In preparation for the upcoming season, Tax Pros Seneca has some tax tips for you, some reminders for making your appointment and things to bring.

Here are some tax tips for you. First, you can still contribute \$300 or \$600, single or married filing joint, to a charitable organization before January 1, 2023, and deduct it whether you itemize or not. This law has not been approved for the 2023 calendar year so this might be the last year we get the extra charitable deduction. The Child Tax Credit went back down to \$2,000 from \$3,000 and there is no extra amount for dependents younger than 6. The standard deductions for 2022 are \$25,900 married filing joint, \$19,400 head of household, and \$13,850 single. The 2023 standard deductions are scheduled to increase to \$27,700, \$20,800, and \$13,850 respectively. We have never seen such a large increase in this deduction. If you do itemize in 2022 you might want to pay property taxes and any other itemizing deductions before year end, especially in light of the increase in standard deduction. If you claim mileage for a business the mileage rate for 2022 changed on July 1, 2022 to 62.5 cents per mile from 58.5 for the first half of the year. *Please have mileage for January to June separate from July to December.*

This year you can call and make an appointment for your tax return preparation. You can also use our website [www.taxprosseneca.com](http://www.taxprosseneca.com) to schedule your appointment. Most of you know we have moved to 10131 Clemson Blvd, Seneca, SC 29678, but we just wanted to remind you again. Included with this delivery is your audit retainer form, complete it and send it back now or bring it with you to your tax appointment.

Don't forget to bring all documents to your tax appointment or include them when you drop off your tax information. One item that is usually forgotten is your HSA forms showing the distributions for the 2022 year. Most employers don't automatically mail that form so you may need to log in to your HSA account and download it.

If we have your email on file then you received this letter and organizer there. This organizer will have data from 2021 and will help you remember all the items you need to bring if they are the same as last year.

We are excited to say that Tiana Seavey will be accepting appointments as well this year. She has spent the past year strengthening her knowledge of tax preparation and studying hard for the Enrolled Agent Exam. You can schedule with either of us when you call in to make your appointment.
