## **RALLY JUMP HEIGHTS**

Rally classes with jumps will be judged in Jump Height Order from Low to High both Saturday and Sunday.

**PLEASE INCLUDE JUMP HEIGHTS ON YOUR ENTRY FORM.**

Rally Jump Heights Are As Follows:

<u>Height of dog at withers:</u>	<u>Jump Height:</u>
Less than 10"	4"
10" to less than 15"	8"
15" and under 20"	12"
20" and over	16"

**There will be two rings for Rally, Ring #1 and Ring #2. The size of both rings will be 40' x 50'.**

**NOTE TO RALLY EXHIBITORS:** YOU ARE EXPECTED TO UNDERSTAND THE RALLY REGULATIONS AND UNDERSTAND WHICH RALLY CLASS (A OR B) AT ANY LEVEL TO ENTER. **THE TRIAL SECRETARY WILL NOT ADVISE YOU WHICH CLASS (A OR B) YOU SHOULD ENTER.** The rules differ between the Rally Novice, Intermediate, Advanced, Excellent and Master classes. **BE ADVISED THAT YOUR LEG WILL NOT COUNT IF YOU EARN IT IN THE WRONG CLASS!** If you have any questions about which class to enter, consult the AKC Rally Regulations at [www.akc.org](http://www.akc.org).

For Rally trials, a Recording Fee of \$3.50 for first entry and \$3.00 for each additional entry of the same dog shall be collected. These fees are to be collected by the show-giving club and paid to the American Kennel Club. The fees are included in the entry fee for this trial.

Entry fees shall **not** be refunded in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge or barred from competition by action of the Show Committee. One half of the entry fee will be refunded upon request to the trial secretary for a bitch coming in season after the closing date of entries for this obedience trial, provided the secretary is notified prior to the date of the trial. Full refunds will be made for bitches that come in season provided the secretary is notified prior to the entry closing date. No refunds will be made on the day of the trial.

***ENTRIES ARE LIMITED to eight hours of judging time PER DAY, PER JUDGE.***

**CATALOGS:** If you would like to purchase a 2 day catalog, please prepay with your entry fees. We will be making enough catalogs for prepay exhibitors and only a minimal amount thereafter. If you do not prepay for your catalog and want to purchase one on either day, you may not be able to get one.

ALL DOGS SHOULD BE PRESENT AT LEAST 30 MINUTES PRIOR TO JUDGING. THE HANDLER IS SOLELY RESPONSIBLE FOR HAVING THE DOG AT RINGSIDE. THE JUDGE NEED NOT WAIT FOR ANY DOG HOLDING UP A CLASS. **WE WILL NOT CALL FOR YOU.**

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal parasites, any communicable diseases, and have appropriate vaccinations.

It is expressly understood that the exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any entry fees will be made.

The Indian River Dog Training Club, its agents, etc., assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers or to any of their dogs or property and further assumes no responsibility for injury to children.

The use of spiked or other "special" collars or anything hanging from the collar is prohibited at this or any other AKC rally trial. Exercise pens **are not allowed** inside the building!! **LIMITED SPACE PROHIBITS INDIVIDUALS AND DOGS NOT ENTERED IN THE TRIAL!**

## DIRECTIONS TO TRIAL SITE

From North U.S. 1

Travel south approximately 2 miles from the Route 192/U.S. 1 intersection

Turn right onto Conlan Blvd.

Turn left at 2<sup>nd</sup> traffic light (Kirby Cir.) & immediate right into trial site parking lot.

From South U.S. 1

Travel north approximately 3.5 miles from the SR 514 (Malabar Rd.)/U.S. 1 intersection

Turn left at traffic light onto Conlan Blvd.

Turn left at 2<sup>nd</sup> traffic light (Kirby Cir.) & immediate right into trial site parking lot.

From I-95 North & South

At exit 176 turn left onto Palm Bay Rd. if coming from north & right onto Palm Bay Rd. if coming from the south.

Travel approx. 3.5 miles to the Palm Bay Rd/Conlan Blvd. intersection.

Turn left at traffic light; stay in right-hand lane.

Go approx. 1/4 mile to 1<sup>st</sup> traffic light. Turn right into parking lot just before the traffic light. Building is on the right at that intersection (RJ Conlan Blvd. & Kirby Cir.)

(Variety) If you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e. Cocker Spaniel (solid color, black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachsunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
