How ABP provides new financial and operational insights to support better decision-making

Overview

This 3-hour On-Demand workshop hosted by K2E, covers the fundamentals of activity-based planning (ABP) and how it can be used to enhance resource deployment, cost management, and operational planning in any organization. Participants will learn basic ABP principles that provide better insights into resource capacity management, business process optimization and improved operational costing.

Details

Business models created using ABP concepts provide valuable insights into how organizational resources support the business activities required to deliver on product and service commitments to customers. These models visually demonstrate how resource expenses can be traced through business processes to develop accurate information for the determination of true product and service costs as well as improving operational budgeting. Since these business models are "constraint-based", they can also be used in "what-if" analysis to better forecast the cost and impact of changes in process efficiency or product/service demands.

This workshop employs group breakout session exercises to help reinforce the understanding of ABP concepts. It also demonstrates the value of employing leading-edge ABP technology that provides users across the organization with highly-visual and interactive business models which further enables a collaborative approach to develop and understand the operational and cost flows of any business process. ABP ultimately provides a shared environment for operational, financial and strategic managers and planners to develop a common understanding of the key operational factors influencing costs and budgets.

The ABP methodology presented is based on the research conducted by the **Consortium** for **Advanced Management** – **International (CAM-I)** and popularized in its ground-breaking book, "The Closed Loop". Finance professionals are encouraged to attend with their operational and/or strategic planning colleagues to this workshop to fully realize the benefits of this collaborative approach to business process management.
