PRICING & BILLING POLICY

BEGINNER - 1 CLASS PER WEEK, 1 HR: \$80 per month

BEGINNER - 2 CLASSES PER WEEK, 1HR: \$150 per month

ADVANCED - 1 CLASS PER WEEK, 2 HRS: \$100 per month

ADVANCED - 2 CLASSES PER WEEK, 2 HRS: \$150 per month

Classes are held on a weekly basis. We do offer a sibling discount of 10% off the 2nd child, 3rd child. **Fees are due on the 1st of the month prior to classes. After the 3rd a late fee will be charged of \$30. If payment is not made by the 10th of the month, the child will be dropped from the class.** Payment can be made in cash, check or credit card. For credit card, an invoice will be emailed to you. Some months will have 3 weeks, some will have 5 weeks, most will have 4 weeks. Your billing is based on 4 weeks and does not change for more/less weeks. In addition,

there is an annual registration fee of \$99, due Sept 1st. Registration midyear will be prorated.
