Scope of Warranty

Genesis Dental Technologies, LLC, manufacturer of AguaSept/AguaFit ("Genesis") warrants to the original retail purchaser that the AquaSept/ AquaFit branded products will be free from defects in material and workmanship under normal use and service for a period of one year from the date of invoice. Warranty includes parts and labor. Shipping costs are excluded. This limited warranty shall only apply to defects that are reported to Genesis within the warranty period and which, after examination by Genesis, prove to be defective. If Genesis finds the product to be defective during the applicable warranty period, Genesis shall correct any such defect by either, at Genesis' sole option, repairing or replacing any defective or non-conforming product, or defective or damaged part, as applicable. This warranty is not transferable or assignable.

Discontinued parts and accessories, and parts not supplied by AquaSept are excluded from this limited warranty. Genesis shall not be responsible for dismantling or re-installation of any AguaSept/AguaFit part. Any defects in a repaired or replaced part shall be covered to the extent of the unexpired term of the original warranty period. Warranty does not cover consumable parts, or normal wear, or any goods that have been supplied by any company other than Genesis. 


Drill a 7 mm hole into dental unit. remove nut and insert quick connect through hole. Fasten nut onto quick connect with 11 mm wrench.


Hanger Mount Instructions:

Remove nut from quick connect and discard. Thread quick connect into hanger mount with 12 mm wrench.





F Quick Connect Collar **IMPORTANT NOTICE:** Do not operate handpiece above 40 psi. Damage may occur to the bottle if the system is operated above 40 psi. Do not use any chemical solutions, chlorine-basedcleaners or saline solution with AquaSept[™] units. The water pathway may become compromised if the above solutions are used on AquaSept[™] units. CAUTION: Do not plug a High Speed

Handpiece System into a syringe mount, the turbine will rotate immediately.

Visually inspect your AguaSept[™] system for tears or holes in the tubing before each use. If any of these defects are observed, do not use the system. CAUTION: Regulator is fixed to deliver 12-15 psi air to syringe rather than line pressure. Regulator must be used. Supply flow restrictor (if used in the unit) should be opened or bypassed.
