5. Program fee is due on the 1<sup>st</sup> of each month. Lack of payment by the 5<sup>th</sup> of the month results in a \$35 penalty late fee and may result in immediate eviction.
6. A sober/damage deposit will be required before residency begins.
7. The above-mentioned deposit will be returned within 30 days of vacancy if entitled.
8. At least 30 days' notice is required from house members to end the Housing Agreement (if you have completed or will have completed the 3-month minimum duration).
9. Any damage or misuse of private property can result in immediately being asked to leave.
10. No sexual partners or other guests will be allowed at any time on the premises with mgmt. approval.

Any use of Alcohol or illegal drug(s) will immediately result in eviction. Disputes of use will be managed via local officers brought onto the premise. Furthermore, the remaining payment of the residents' entire lease will be required in full along with no return of security deposit (given additional cleaning, selling of the unit, and moving expenses added to ANEW operating costs.
