****A non-refundable deposit of ½ the purchase price is required to hold a puppy of choice.****

If deposit is made before a litter is born, deposit may be transferred to another litter if there is not a puppy in litter of buyers liking or if a puppy of sex preference was not born. Deposits may be made by Cash, Personal Check, Venmo or Pay Pal. The total price due must be paid in full at 3 days of age if there is a preference on docking of tail or before delivery of the puppy of tail is within guidelines of AKC standards for this breed.

TonKa's Standard Poodles reserves the right to "FIRST" pick from each litter if so desired, even when deposits are made.

Shipping

Shipping is available via ground transport, air, or seller can also meet buyer partial way for a fee, or fly in to the OKC, Will Rodgers World Airport and Seller will meet there and puppy can fly home in cabin with buyer. **Shipping expenses will be paid by the buyer and paid in full 7 days before the puppy will be shipped.** Puppy will come with an Oklahoma State health certificate That meets all state local and US requirements for shipping.

My guarantee

Your puppy will have had all the necessary vaccinations and de-worming's at the time of shipping or pickup/delivery and will have been examined by a licensed Veterinarian prior to leaving my premises. I guarantee, to the best of my knowledge, that I am sending you (the buyer), a healthy puppy. If the purchase of the pup is for **LIMITED** registration, registration papers **WILL NOT** be sent with the puppy to the buyer until proof of spay/neuter is sent to the seller and verified, at that time registration papers will be mailed out and marked limited. If puppy is sold with full breeding rights the registration application will accompany the puppy.

Buyer's Responsibility

Owning a puppy means occasional trips to the vet. You, (the buyer), are responsible for all costs of these trips. **Take your puppy to the vet within 72 of arriving home for an exam, or this contract is VOID.** It is up to you to provide your puppy with the routine preventative care it needs, annual physical exams by a licensed veterinarian and following the veterinarian's guidelines for vaccinations and de-worming's are the sole responsibility of the buyer.

TonKa's Poodles will not be responsible for any medical expenses incurred.

Health Guarantee

During shipping, puppies can become stressed by the change in environment. Minor problems such as diarrhea, coccidia, upper respiratory, kennel cough, etc. may occur and must be treated. These conditions are the responsibility of you, (the buyer), not the seller, and should be checked by a licensed Vet. These and other minor health problems are not covered by this guarantee. And minor problem that can be cured by medication is not covered by this guarantee. Any existing conditions listed in advance will not be covered by this guarantee. This guarantee does not include any injuries or problems the puppy develops due to neglect or abuse by the new owner.

Your puppy is guaranteed for 1 year of age against fatal and life altering congenital diseases, this includes hip dysplasia, heart and liver problems of a severe, life-threatening or altering nature are also included. In the unlikely event this occurs, Breeder must be notified within 48 hours of the licensed Veterinarian's determination. At your (the buyer's) expense. I may require TWO reports from TWO UNASSOCIATED LICENSED Veterinarians, both must state the same diagnosis. If the puppy is diagnosed with hip, elbow or patella issues/dysplasia, I require copies of the x-rays. There are certain disorders which may be caused by environmental conditions. For example: allergies, thyroid dysfunction, mange, and auto immune disorders, even hip, elbow, patella problems can be deemed environmental and those are not covered by this guarantee.

TonKa's Poodles cannot and will not guarantee color or size of puppy as an adult. If at any time buyer ca not keep the puppy/adult, we reserve the right to have first option to buy puppy/adult back, if this is not an option at the time then the buyer can re-home said puppy/adult. A returned puppy must be returned to the seller in good condition other than the specific problem. In the unlikely event the puppy should die within the 2-year time frame, you (the buyer) must pay to have a necropsy done on the puppy to show the reason for the death. The necropsy report must show, without a doubt, the reason for the death was congenital. I will only replace a puppy with a puppy from the next available litter. **NO REFUNDS WILL BE GIVEN.** The replacement puppy may or may not have the same parents. No puppy replacement will be given if the original puppy has been euthanized, spayed or neutered without our permission. Any physical problem occurring from injury to the puppy is not guaranteed. You (the buyer) are responsible for transportation cost to and from the seller on a replacement puppy.

This Guarantee only applies to the original owners of the puppy. If the puppy is sold to another party before the age of 1, this guarantee is **VOIDED.**

If there are any disputes or legal matters having to do with this sale, they must be resolved Custer, County in the state of Oklahoma.
