TonKa's Poodles and Buyer agree to enter into this contract under the following Binding agreement:

This Agreement insures the buyer a puppy from the next available litter. The deposit is non-refundable but transferable to the next litter should something happen out of breeders control.

This Agreement is for the _____ litter. Due on or about _____.

Shall the above litter not produce a puppy suitable to the buyer then the deposit will be transferred to the next litter. The buyer must pick a puppy within 1 year of date of this agreement or forfeit the deposit.

TonKa's Poodles will warranty the puppy purchased free from genetic defects that prevent the puppy from being a breeding animal. If this contract is for a puppy this warranty is in effect until the puppy reaches 2 years of age. We cover Hips, Elbows, Eyes, and Patella's, on puppies sold for breeding purposes. If any defect is found, on or before the puppy's 2nd Birthday breeder must be notified within 24 hours of findings. Documentation from a licensed veterinarian must be provided to the breeder. Breeder then will replace said puppy with one of the same sex from the 1st available litter (puppy to be determined by breeder). No money will be refunded. Please see Buyer's Contract with Breeder for full Detail.

The puppy/dog shall be returned to the breeder at buyer's expense in a well-cared for condition unless it is deemed necessary for the puppy to be put to sleep. Course of action to be taken will be determined by the breeder and the breeder's veterinarian.

Buyer has 72 hours to have the puppy seen by a board-certified veterinarian to have the puppy/dog examined for general health from date of delivery/pickup.

Breeder accepts no liability for communicable diseases after the 72 hours of when the puppy left the breeders possession. If a puppy/dog does not pass a general health exam by a licensed veterinarian buyer agrees to notify the breeder within 24 hours with a copy of a signed licensed veterinarian statement of health. Minor problems such as diarrhea, coccidia, giardia, intestinal worms, parvo, etc. are not and will not be covered by this warranty. These are things that can be out of a breeder's control. We have made every effort to ensure your puppy has had all its vaccines for its appropriate age, deworming's, etc. we will not be responsible for things that occur naturally or environmentally in your puppy. Breeder will not be responsible for any of buyer's veterinary expenses.

Breeder cannot and will not guarantee adult size, conformation, eye color of a puppy breeder makes no warranties to litters produced from this animal.

Buyer hereby releases breeder and agrees to hold harmless for any liability injuries, or damages to person or property caused by puppy/dog _____

Buyer shall assume full responsibility for the health, temperament, and appearance of the puppy upon the puppy leaving the premises of the breeder _____

Buyer must follow the recommended vaccine schedule, deworming schedule and heart worm schedule of their veterinarian _____
