Tonka's Poodles and Buyer agree to enter into this contract under the following Binding agreement:

Tonka's Poodles/Breeder warrants this puppy/dog free from genetic defects that prevent the puppy from being a pet/companion animal only. If this contract is for a puppy this warranty is in effect until the puppy reaches one year of age. If any defect is found breeder must be notified within 24 hours of findings. Documentation from a licensed veterinarian must be provided to the breeder. Breeder then will replace said puppy with one of the same sex from the 1st available litter (puppy to be determined by breeder). No money will be refunded.

The puppy/dog shall be returned to the breeder at buyers expense in a well cared for condition unless it is deemed necessary for the puppy to be put to sleep. Course of action to be taken will be determined by the breeder and the breeder's veterinarian.

Buyer has 48 hours to have the puppy seen by a licensed veterinarian to have the puppy/dog examined for general health from date of delivery/pickup.

Breeder accepts no liability for communicable diseases after the 48 hours of when the puppy left the breeder's possession. If a puppy/dog does not pass a general health exam by a licensed veterinarian buyer agrees to notify the breeder within 24 hours with a copy of a signed licensed veterinary statement of health. Minor problems such as diarrhea, coccidia, giardia, intestinal worms, parvo, etc

are not and will not be covered by this warranty. These are things that can be out of a breeders control. We have made every effort to insure your puppy has had all of its vaccines for its appropriate age, dewormings, etc. we will not be responsible for things that occur naturally or enviornmentally in your puppy. Breeder will not be responsible for any of buyers veterinary expenses.

Breeder can not and will not guarantee adult size, conformation, eye color of a puppy breeder makes no warranties to litters produced from this animal.

Buyer shall have puppy/dog spayed by 6 months to 1 year of age _____

Buyer hereby releases breeder and agrees to hold harmless for any liability injuries, or damages to person or property caused by puppy/dog _____

Buyer shall assume full responsibility for the health , temeorment, and appearance of the puppy upon the puppy leaving =g the premises of the breeder _____

Buyer must follow the recommended vaccine schedule, deworming schedule and heart worm schedule of their veterinarian _____
