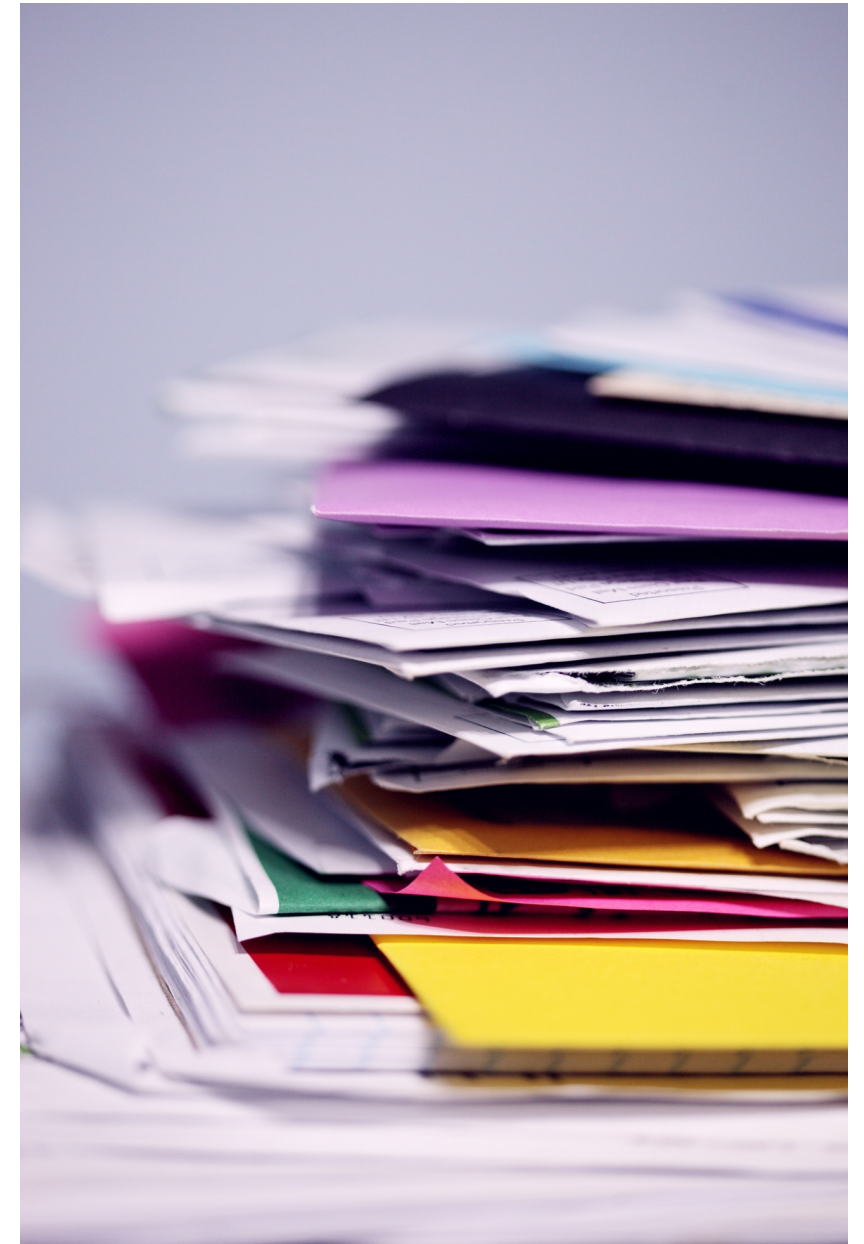

Recording financial transactions like sales, purchases, income and expenses in accounting journals.



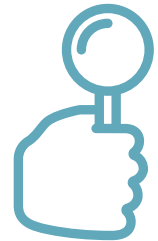
Payroll

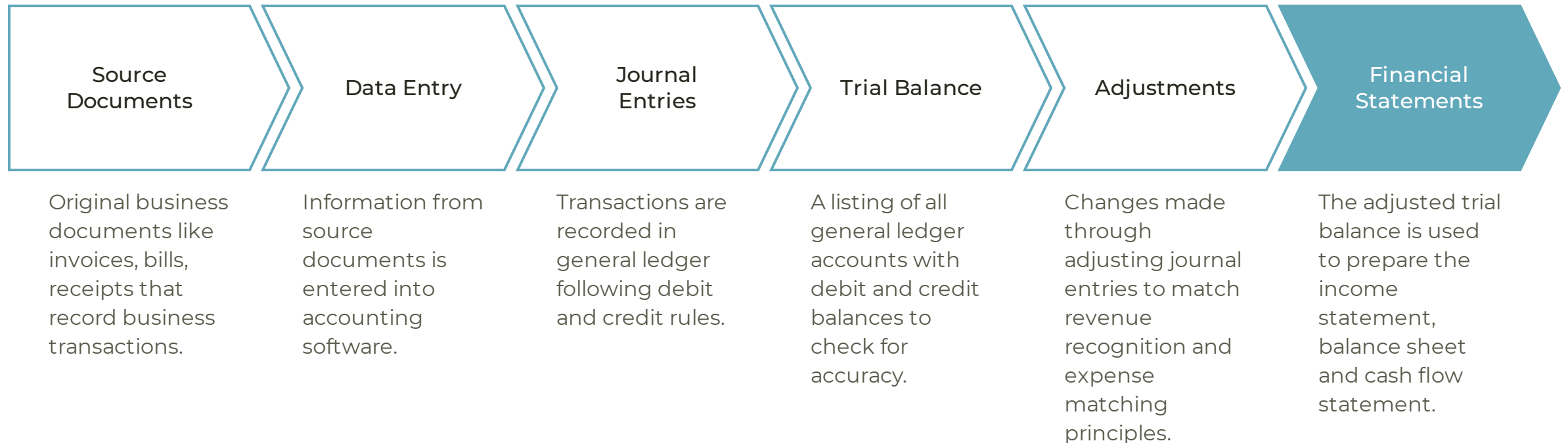
