

2025 The *NEW* GREEN COUNTRY INVITATIONAL SALE

Rules

The *NEW* GREEN COUNTRY INVITATIONAL will be held at the OKMULGEE COUNTY FAIRGROUNDS MAY 3, 2025. Consignment check-in will be from Noon to 5:30pm Thursday, May 1st, or 8:30am-10:00am Friday, May 2nd. The GCI Meat Goat Conference will be Friday May 2nd, with events and speakers TBA. Your host farms are: Stoney Creek Kikos & Square One Kikos

REMINDER – This is an **INVITATIONAL** sale put on as a platform to sell quality Kiko goats and market your farm. As an invitational sale, it is in the best interest of both the sale and your farm's reputation to bring your best animals. An invitation to consign this year does not automatically mean you will be invited to next year's sale. If you bring subpar animals (i.e. poor condition, unthrifty, poor examples of the kiko breed), if you do not help with unloading/sale activities/load out, are not a pleasure to be around, or you consistently miss deadlines, you may not be invited to participate in future sales.

Have fun, bring your best, and enjoy the camaraderie!

There are a few changes from past sales. Please be sure to read the new rules completely. These changes were made in response to feedback and concerns from prior sales. If you are unhappy with any changes, feel free to contact me to have a discussion regarding the changes below.

- **MUST be a current and in good standing NKR Client**
 - **Consignments MUST be NKR registered**
 - **Consigners are only allowed to consign ONE (1) doe without their own herd prefix***
 - **No does (or kids) with improper teats/knots/defects**
 - **If deemed necessary, consignments may be drug tested**
1. **Deadline.** The deadline for nominating your does for the sale and fees will be **JANUARY 10, 2025**. There will be a maximum of **100 does** and **10 semen/embryo lots** in the sale. Semen lots will be **2 straws per lot**. Consignor must nominate at least **2 does** in sale to qualify for semen/embryo consignment. There will be a maximum of **1 semen or embryo lot per consignor**. The first **10 semen/embryo consignments** received will be accepted.
 2. **Consignments.**
 - All does nominated to the sale must be registered with NKR.
 - Only **100% New Zealand or Purebred** does with **Parentage Verified (PV)** status will be accepted.
 - All doe consignments must be at least **5 months old** but **not greater than 5 years old** at time of sale (**MUST BE born by Jan 3, 2025** and **not before than May 3, 2020**).
 - Only ONE doe consignment will be allowed with another's prefix per consigner- **at the management's discretion*.
 - **No bucks** will be accepted for the sale, but you may bring bucks and sell them via private treaty from your trailer at no charge.
 3. **Defects.** On arrival, all does will be inspected for defects including but not limited to **knots, growths, cloudy eyes, ORF or lameness**. Does without proper 1X1 teat structure will not be

allowed to go through the sale ring. This includes fish teats, blind teats, extra teats/visible or extra/double orifices. Any defect found will be shown to the consigner and they will be required to withdraw the lot and will not be reimbursed any consignment fees.

4. **Families.** When entering a family lot, **only the doe** must meet age requirements, have NKR registration papers (Unless a recipient doe with embryo transfer kids), and a current health certificate. Each kid must be eligible for **100% NZ** or **Purebred** designation and have a completed **NKR Application for Registration**. Kids will be inspected for defects as does are. If any defects are found, kids will not be allowed through the sale ring. If the kids do not DNA match the parents listed on the application, it is the seller's responsibility to correct the issue with the buyer.
5. **Semen/Embryo Lots.** A Semen or Embryo lot consignment will only be available to those who have consigned does in the sale, limited to 1 per consignor (for total of 10 lots MAX).
 - Semen or Embryo lots will need a sales packet; see Section 11 below.
 - Semen lots will be limited to one (1) per consigner and must be two (2) straws of the same buck, no packages.
 - Semen lots will be sold as one price for both straws, not individually priced.
 - Embryo lots will be limited to one (1) per consigner 2 embryos per straw in one straw lot.
 - It is the responsibility of the seller and buyer to make plans for the release and/or transport of the semen or embryo lots.
6. **Consignment Fees.**
 - The consignment fee for each doe consigned will be **\$140**; this includes the internet fees, transfer fee, shavings and cleaning. The entire consignment fee (\$140 per doe lot) is due by time of nomination.
 - The fee for each semen or embryo lot consigned will be **\$75.00 per lot** due at time of nomination.
 - **Nomination Fees are Non-Refundable and must be received by JANUARY 10, 2025**

7. **Registration Paperwork & Seller's Comments.**
 - Please submit any new registration applications early to allow time for DNA verification and pedigrees back by March 1st.
 - Ensure copies of your registration papers are clear and legible. For best results, use a scan app such as **CAM SCANNER** if photographing the papers with your phone.
 - Seller's comments for the catalog should be short and to the point due to catalog space.
8. **Catalog Cut Off Date.** We must have copies of your registration papers and photos of does by **March 1, 2025** to ensure the correct information in the catalog. These can be either emailed to thenewgci@gmail.com or sent by mail, but **MUST** be received by **March 1, 2025**. Any nominations missing paperwork will be replaced by another breeder nomination on **March 2, 2025**. We aim finalize the catalog as soon as possible and time is required for review, corrections and/or substitutions that need to be made.
9. **Farm Ads.** If you would like to place a farm/ranch ad in the catalog, your ad information or ad copy must be submitted by the **March 1st deadline**. See Ad sheet for Ad pricing.

10. **Arrival Time.** All consigned does should arrive between **Noon-5:30pm Thursday (5/1/25)** or **8:30am-11am Friday** morning (5/2/25). If you are unable to make the drop-off windows, please contact us ASAP to make alternate arrangements (NO drop-offs will be accepted later than 5:30pm). **When you drop off your animals, we would appreciate it if you could assist unloading other consignments.** Water and small snacks will be available.
11. **Upon Arrival at Sale.** All consignments must arrive with the following documents. If you are missing documents, your doe may not be accepted into the sale:
1. An interstate health certificate issued at the point of origin (your home state) by a federally accredited veterinarian. The health certificate must reflect the consignment to:

2. A 9 x 12 envelope with: your farm PREFIX on TOP left corner (Animal name below that), EAR Tag number top center (or the words; SEMEN / Embryo) and LOT number TOP Right (Write "SUB" below lot if needed) containing the following items:

- Original registration papers
- Signed transfer form
- Photocopy of health papers with the animal highlighted
- Photocopy of registration papers for the buyer
- Sire service memo (if exposed to a buck prior to the sale)
- NKR "Application for Registration" per kid (if selling family groups)
- Any other relevant test results, health records, or DNA reports
- Semen/Embryo lots must also include a 9x12 envelope with a copy of the pedigree, location of straws, and contact info for the buyer.

All of these forms are available on the NKR website. If you have difficulty finding them, please contact us at thenewgci@gmail.com All does must match the identification on the registration form regardless of type. Please make sure that any microchips or tattoos are readable prior to arrival. **If they are not readable you will have to re- chip or re-tattoo before animal can sell.** Scrapie tags must be present on the animal.

12. **During the Sale.** Cooper Sherrill is announcing the sale. Help him help you by providing good concise information on your consignments in a timely manner!
