



Terms of Hire for items hired:

If you hire Snap That! Photo Booths and Event Supplies Items/ Props, you are agreeing to comply with and be bound by the following terms and conditions of hire.

1. Booking

Full payment is required before your booking can be confirmed - this can be made by cash, Paypal, or bank transfer. We regret that we cannot confirm your booking in the diary until payment has been received.

2. Loss or Damage

The Customer assumes complete responsibility for loss of or damage to the items from the time it is collected/delivered to it being returned/collected. **If any items are lost, stolen, or is damaged beyond repair you will be liable for the full cost of replacing the stated items.** We recommend you take out wedding/event insurance for such instances.

3. Care of the hired items specified.

By hiring items from SnapThat! Photo Booths and Event Supplies you are agreeing to keep good care of them whilst in your hands. If they are being delivered to your venue or any third party, you are responsible for ensuring that all items are stored in a safe and secure place for the entire duration of your hire period.

Any damage to any of the stated items will be noted on its collection/return. You are responsible for any damage caused by third parties e.g venue staff if they are dealing with the items on your behalf. Therefore please ensure that they are aware that all items must be handled with extreme care.

If you are hiring our Post box, please note that the key must be returned with the Postbox. If you lose the key, a charge of £15 will be made to cover the costs of replacing it.

Please ensure that the Postbox is also emptied of all cards before it is returned to us. Any that are left inside we will be happy to send on to you but will need you to cover the postage costs.

If you are hiring our light up LOVE letters, please ensure the equipment is kept safe and protected against adverse weather as well as against risk of loss or theft while at your venue.

4. Late Returns

You are required to return all items to us at the pre-agreed time. Often, the items will be hired out over consecutive days so **it is vital that it is returned to us at the correct time in order that it does not delay future bookings.** If any of the items are returned to us late, an additional £10 hire charge will be payable for each hour it is late. These charges may be waived at our sole discretion and only if there is no booking that the late return impacts upon.

If we are collecting said items from your venue, you are responsible for ensuring that it is available for collection at the pre-agreed time. If the venue is closed or the items are not at the venue, an additional charge of £20 will be payable to cover lost time & travel costs. The above charges for late returns will also apply for each hour that any of the items hired are not available for collection.

5. Termination of Liability

Snap That! Photo Booths and Event Supplies shall be relieved of all liability for obligations incurred to the Hirer and any other third party. Snap That! Photo Booths and Event Supplies shall not be responsible for injury or damage to persons or property howsoever sustained arising from the hire of the stated items.

6. Retention of Title

All items hired out will remain the absolute property of ‘Snap That! Photo Booths and Event Supplies’ and the customer shall not sell, offer to sell, underlet, lend or otherwise deal with any of the hired items.

7. Law

This contract shall be governed by English Law in the Courts of England.
