The requester must provide the Club Executive with approved SFOC copy document along with a copy of own insurance, and stating that his Organization, the KMAC , its Members, and executive and MAAC, and if required the property owner are all named as insured under that policy. Copies to be forwarded to the Zone Director for approval before the first flight. Upon approval the Zone Director will issue written permission to operate at the flying site with the understanding that the operator will at all times operate in full compliance stated in the MAAC and SFOC rules.

I agree when using the Keswick Model Club Inc. flying field, to abide by its rules as set by the Club and its executive committee. Violation of Club rules, safety or otherwise, could result in loss of Club privileges.
