As 2024 comes to a close, I can't help but be proud of all we have accomplished and all that we are taking on. The congregation continued to show up with time, talents, and financial giving. We pulled together through breaking bread dinners, coffee hour before service, an abundant fellowship table after service, and other creative ways to interact with the community like Octoberfest and the Holiday Parade. Bread of Life Pantry, a cornerstone of our mission, fed more families than ever. 2024 was truly an embodiment of Faith, Food and Family.

We welcomed new members and with them their talents as well. It's been great to see others feel "right at home" in our community, but even more so, the engagement these new members bring! As the congregation takes new shape, so did the worship space with the donation of 2 big screen TVs and Pastor's adoption of these digital tools to make service more dynamic and accessible. Council met for retreats at local businesses in Salem this year and got feedback from young people on their ask for digital tools, so we'll be forming a subcommittee in 2025 and looking for your time and talents to find new ways to bring Christ's message to others.

Youth ministry continue to be strong. We saw many little ones get baptized in Christ this year but also strengthened our children's understanding of God's love through a robust Sunday School program. The learning was for all ages too, with programs like Pastor's Lutheranism 101 class and viewings/discussion of The Chosen. We also worked to strengthen our support and connection with young adults in the congregation through fellowship events specifically for teens and a new youth room with gaming systems. Growing up is hard, and this helps meet these new missionaries where they are at to show them they will always have a safe space here in our community.

As we look forward to 2025, I'm excited about what we are working on and talking about taking on with our unique talents. There is passion in the congregation to take our mission to new heights with a lot of creative and loving ideas. I'm looking forward to continuing to feed the poor, care for those hurting, and to being the messengers Jesus called us to be.

ORDINATION OF GAIL ANGELLIS on June 16, Father's Day – It was a special blessing to witness and participate in the ordination into ministry for Gail, a lifelong member of TCLC, who has also blessed us by her own faith journey and now serves as Pastor of Emmaus Lutheran Church in Falmouth, Maine. It was indeed a special day, with Bishop James Hazelwood present to preside at her ordination, along with many other clergy present to participate and celebrate.

ALL SAINTS' SUNDAY – On November 3rd, we remembered members and friends with the reading of names of the saints, ringing of chimes, and lighting of candles. Pastor Scott led a brief prayer time in the memorial garden following the service.

ADVENT & CHRISTMAS was a busy and festive time as always. St. Lucia Sunday was celebrated on December 15th with the traditional procession of St. Lucia (Morgan LaFleur) and her court. A beautiful Christmas Pageant, "The Stars of Christmas," was celebrated on Saturday, December 21, along with a pot-luck supper. The pageant was coordinated and directed by Liz Aiken, assisted by Emily Howard, Debby Lovejoy, and Pastor Scott, with a wonderful cast of Storytellers; Star; Mary and Joseph; Townspeople; Shepherds; Angels; Animals; and Kings.

INTERFAITH CHOIR CONCERT - Our church hosted one of the Christmas concerts given by the Interfaith Choir, along with The King's Singers, a wonderful youth choir.

In the spring, Rebecca's friend Zaray Rossi gave a master class one Sunday for the choir to learn new singing techniques. She also sang special music during the worship service.

The CHOIR ROOM needed a thorough cleaning due to extensive mold. The robes were taken to be professionally cleaned, with a generous discount given by Daisy Cleaners, and funds from the Memorial Fund. Craig Cunningham took care of the mold remediation situation. Once again, many thanks to Craig for all his work behind the scenes with many projects, including his technical expertise providing our on-line worship every week.

The BELL CHOIR handbells were fully refurbished with new handles, clappers, and polish thanks to the Arndt Fund and gift from the Claussen family.

WORSHIP SPACE SCREENS – An addition to our worship spaces was the installation of two screens, providing visual aids for worship themes as well as assisting visitors to navigate where we are in the service. These have been proven to be effective and useful tools in a technological world.

THE CHOSEN



Beginning in 2023, Pr Scott led a regular viewing and discussion of the online TV series. The Chosen. Directed and produced by Dallas Jenkins, the series follows the disciples of Jesus as they are called, challenged, and grow into their roles as people of faith and followers of their charismatic controversial rabbi. The series aims to be faithful to historical accuracy and the spirit of the Gospels, and presentation of Jesus and his disciples is remarkably relatable and enjoyable.

The viewing and discussion of Season Three was completed in the Spring, and Season Four was enjoyed in the Fall. Candy L. donated the first four seasons on DVD to make viewing easier. Plans to coordinate viewing parties at the theater for the cinematic release of Season Five in the Spring of 2025 are underway.

SUNDAY SCHOOL

Megan Neeb served as our Sunday School Superintendent in the Spring of 2024, leading the weekly program for grades K-6 at beginning at the end of Holy Communion and spilling into the fellowship hour. Megan stepped down from her role in the summer as she has began a new master's degree in the Fall. 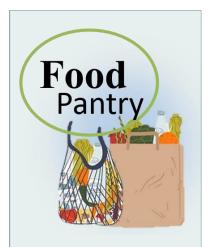

BREAD OF LIFE FOOD MINISTRY

In 2024 it continued to be challenging for families to keep up with high prices, as well as the uncertainty of supplies in all the stores. This also reflected in the supplies coming from TEFAP-USDA (Emergency Food Assistance Program) and NH Food Bank. Both these sources supply our bulk supplies. When I place the orders, sometimes they didn't have items we needed, other times they had an overabundance of needed items which makes planning ahead difficult. But shelves were kept well stocked, and clients were well supplied with the basics.

On Monday mornings clients were greeted by rotating crews that could include Emily N., Patti McD., Mischele K., Dave H., Judy K., Joe P., Joseph C., Greg D., Tom P., Erin Y., Joy P., and myself. This year we were able to purchase "grocery carts" (thanks to Dave H.) which were a big help to clients in bringing food to their cars. Thursday evenings also included rotating crews of Shannon, Erika, Barb, Heather, Ben, Sarah, Ginny, Erin, Karl, Keith, and his son Jacob. Everyone is well tuned to the procedures of the pantry and can make our clients feel welcome and comfortable.

Food supplies from TEFAP continue to come monthly or bi-monthly (depending on their schedule). Orders are picked up in Exeter, NH by Rick H. and his crew of helpers (Bob McD, Pete, John G, with an occasional mystery helper). These helpers deserve a big thank you for doing this pick-up as they also help We Care Charities by picking up their orders. Food is also picked up at the NH Food Bank in Manchester. Rick and Joseph C pick up our weekly order and are met by helpers (Mischlel, Joe, Judy, Joy) back at the pantry. Through the NH Food Bank Fresh Rescue, we receive frozen meats, dairy items, canned & boxed goods, and many mics items from Salem ALDIs (Fri), Salem Target (Wed), and Plaistow Shaws (Mon). Our teams of Greg D., Dave H., Joseph, Joe, and Dave G., make plans on who goes where on the given day. Dave G. also picked up produce during harvest season from Pete's Farm in Salem – this was the best season for Pete's corn.

We participated in the annual Postal Food Drive (Spring) and the Boy Scout Food Drive (Fall – pickup by Dan and Joe) (estimated donations from each about 400 pounds). We also received many additional donations from food drives by Salem organizations/businesses. Monetary donations received from local organizations and many individuals helped to purchase bulk items (toilet paper / non-donated items) and Thanksgiving gift cards. (Monetary donations from some organizations were lower this year.)

This past year, we served 6,652 individuals from Salem and the surrounding towns. Over Thanksgiving our pantry distributed 112 Thanksgiving Bags (from the congregation). This year each bag included a \$20.00 Market Basket gift card in place of a turkey. The pantry also received 2 donated family size turkey dinners for Thanksgiving and 2 family size Ham dinners for Christmas. Through the Three Seasons Restaurant at Salem High School Culinary Arts program, 100 individual turkey dinners were ordered to be distributed before and after Christmas.

Bread of Life Food Pantry is open Monday Mornings 10am - 12Noon and Thursday Evenings 6:00-7:00pm. Anyone in need of food may come once a week. Participants are asked to fill out an application form (provided by The Emergency Food Assistance Program - USDA) which is kept confidential. Other resource information is also provided.

Anyone interested volunteering in the food pantry in any way (serving, food pickup, help offloading, sorting during food drives, shopping, ...) or if you have questions or would like more details, please contact Ann Rowe at Breadoflife@triumphantcross.org. Thank you to EVERYONE who helps and supports the pantry. We have a "well-oiled machine" when it comes to those working in the pantry. I hope I did not forget anyone.

ONLINE SILENT AUCTION

The 2024 Holiday Silent Auction raised over 15,000. Support for our auction spread outside of our congregation, new sponsors and donors came on board to support our efforts, and we saw a 25% increase in the number of people who registered.

Thank you to our 2024 team members: Carolyn Birr, Erika Escher, Linda Mele, Catherine Morse, Lisa Rebane, Lisa Stift and Elaine Wilkinson for their tireless efforts in making this a success. Gail Corcoran was dearly missed as we planned this event without her. We paid homage to her by updating our logo with a nod to Gail – a gift tag with her initials on it.

OUTREACH MINISTRY

Our mission, as a committee, is to be the eyes and ears of TCLC, to address the needs of our congregation and our community at large. Our projects reflect our mission of Faith, Family and Food. The following is a snapshot of what we have done in the past year.

Bread of Life Food Pantry – Coordinator – Ann Rowe We are open to our clients Monday mornings and Thursday evenings. This is the longest lasting community outreach that TCLC has been involved in. Look for Ann's report elsewhere in this Annual Report.

Family Promise of Southern New Hampshire

- Coordinators – Jeannie Cunningham and John Gay Family Promise is an organization that supports homeless families and helps them gain skills to become independent. They have transformed the Infant Jesus School in Nashua into a new transitional housing that is able to house up to 24 families. On the second Thursday of each month, TCLC provides meals for up to 80 residents. It takes many cooks to provide this food and drivers to bring it to them. Special thanks to Donna Tupper for always driving and a group of about 20 cooks making delicious entrees, casseroles, side dishes, salads, desserts and snacks every month.

Sleep in Heavenly Peace – Contact – Elaine Wilkinson Sleep in Heavenly Peace is a non-profit organization that builds beds for kids in need who have been sleeping on the floor. With groups of volunteers, they build beds and supply bedding.

We held a bedding drive in the spring, donating almost 60 items, including sheets, blankets, comforters, and pillows.

In September, we partnered on a build with Christ the King in Nashua and Messiah in Amherst. TCLC had more than 20 members of all ages and skill levels who volunteered. We built 20 beds (10 bunks), which will make such a difference. It was a wonderful day of faith, family and fellowship.

Our plan for 2025 is to host a build at TCLC.

Gentle Yoga — Contact – Margie McManus

Margie continued to lead one of our ministry's approaches to health and wellness with Gentle Yoga on Saturday mornings, with an average of 5-10 participants ranging from ages 10 to 80+ years.

Ascentria Care Alliance – Contact – Lorinda Rausch

Christmas gifts were donated to this organization for foster children in the program. Wish lists were available for the congregation to select. We sponsored 20 children, another overwhelming response.

Salem Holiday Parade — Contact - Pr Scott

The parade was held on the Sunday after Thanksgiving. The theme was "The Nightmare Before Christmas." Thanks go to the Jahrlings for offering their trailer to be the base of the float and to Craig Cunningham for making railings so children could ride on it safely. A special thanks to Kacey Caradonna for developing the theme and artwork for our float. Thanks to the following individuals and families

who rode or walked the parade route: The Jarres Family, LaFleur Family, Wasley Family, Candi Lavoie, Lisa Stift and of course, our very own Krampus, Pastor Scott. Thanks to Pastor Scott and the Jarres Family for preparing the handouts for the crowd on the parade route, which included candy canes, ornaments, information about TCLC and details of Christmas services.

TCLC Book Group – Contact person – Joy Kimball

This group meets on Thursday mornings from 10AM - Noon. Books are read and discussed, and fellowship is had. Meeting places vary from member's homes and church. New members are always welcome.

Prayer Shawl Ministry – Contact Gloria Zacharias

Handmade knitted or crocheted prayer shawls are available on request. Sign up on the prayer list in the hallway and check off the desire for a shawl. As a recipient of one, I can assure you it was of great comfort. If you do needlework, see Gloria if you would like to be part of this ministry.

Card Ministry - Contact Elaine Wilkinson

This ministry resumed earlier this year. Approximately 5-10 cards are sent to members each month to recognize milestones or simply to reach out to let them know we are thinking of them.

Meal Delivery – Contact – Linda Mele

This ministry helps members of the congregation during times of need. Reach out to Pastor Scott or Linda Mele to request assistance.

AA Noon Mtgs & New Years – Contact – Craig Cunningham

For over thirty years Triumphant Cross has hosted the Salem Noon Time Alcoholics Anonymous Program weekdays at noon. Supporting AA is one of the ways that we can support families in our community. AA provides people with community during their lifelong recovery from alcohol misuse. Since 2021 we have opened our space to host a regional AA New Years Eve Party. This year the party was attended by well over 100 people, for several hours the tables in Fellowship were all full. Many in the congregation contributed food to the event to help make it a success. AA has expressed gratitude for our efforts. We look forward to once again hosting the New Years Eve party in 2025.

Cub Scout Pack 160 — Contact — Bob Stift

TCLC continued to charter and host the Cub Scout Pack 160 as an expression of our community outreach to children and families in the greater Salem area. The pack and its leadership met regularly in our conference room and fellowship hall, including the annual pinewood derby and many playful parties.

Visit with Santa – Contact – Elaine Wilkinson

Our visit with Santa was an item in our silent auction. We also invited clients of the food pantry to attend. Over 30 children had the opportunity to visit with Santa, make crafts, have snacks, and receive a small gift and a picture with Santa. Thanks to Pete, our amazing Santa and to Lisa and Bob Stift and Clix New England for creating a winter wonderland and providing each family with a picture. PROPERTY MINISTRY

The year started out a little rough for the Property Committee when the engine in the snowblower needed to be replaced. We were able to source a new OEM engine from a small equipment dealer in Indiana for a little over \$300 and swap out the engine. The snowblower is now running like a brand-new machine.

At year end 2023 a very generous member donated funds to install two large monitors in the sanctuary. Two eighty-five-inch televisions were purchased and installed during the first quarter of the year. The monitors have enabled Pastor Scott to supplement the service with pictures and other visual aids.

Following the installation of the monitors, we upgraded the church's Wi-Fi network to a system that can support more users at speeds that are more than ten times faster than what we had. As part of the upgrade, we negotiated a new two-year contract with our internet provider at a slight savings over the prior contract. The new network equipment provides more robust coverage in the building and enables us to block traffic to inappropriate websites.

The kitchen is equipped with a grease trap to prevent grease from entering our septic system and leach field, which will significantly extend the life of these expensive systems. This year we found that the grease trap was failing, it was replaced at a cost of \$2500. The new unit should provide 15-20 years of service with regular maintenance.

For several years we've attempted to keep the cross on the back of the church operational. It was backlit by eight special fluorescent lights that used about thirty-five cents worth of electricity each hour that they were operated. This year a member donated money to help pay for an upgrade of the lighting to a ground mounted LED fixture that will cost less than ten cents an hour to operate and will provide years of operation without the need for service. While the electrician was working in the building, we replaced a failed timer for the parking lot lights, repaired exterior wiring that was exposed to the elements, installed electric outlets behind the televisions, and installed a whole building surge protector to protect the congregation's investment in various electronic devices. Within days of the installation of the surge protector the building suffered a surge that knocked out the brandnew surge protector and a special surge protector that had been installed on the fire alarm system several years ago. Our electrician collaborated with a crew from Liberty Utilities to troubleshoot the building and to ensure that there were issues beyond the surge protectors that needed to be addressed.

Finally, as you enter the church you may have noticed that the carpet in the entry way was replaced. FINANCIAL MINISTRY

To begin, the Council and Finance team extend their appreciation to all the members of the TCLC community whose generosity and sacrifice continue to make our mutual ministry happen.
