AGREEMENT

_____ (hereinafter referred to as "STUDENT"), residing at
_____, agrees to pay to

George Flowers (hereinafter referred to as "INSTRUCTOR") a total of \$1,000.00 for ten (10) one-hour voice-over classes, to be conducted at the Ripley-Grier Rehearsal Studios, generally at 520 Eighth Avenue, 16th floor, New York, N.Y. All classes will be taught by the INSTRUCTOR.

TERMS OF INSTRUCTION

1. Instructional sessions are given once per week for ten weeks, and STUDENT shall be assigned a specific day and time. By approving this agreement and paying the required deposit, STUDENT reserves INSTRUCTOR'S services for ten (10) one-hour sessions, and accepts responsibility for compensating INSTRUCTOR for all ten (10) sessions.
2. As soon as all three seats have been filled for the evening and timeslot you selected, INSTRUCTOR will notify you and classes will be scheduled.
3. If for any reason an insufficient number of students commit to the evening and timeslot you selected, INSTRUCTOR will attempt to find another timeslot and/or evening that is agreeable to you. If that cannot be achieved, your deposit will be returned to you, in full. Or you may opt for private classes at \$140.00 each.
3. No make-up instructional sessions are provided for in the schedule. It is STUDENT'S responsibility to be present and on-time for each session. However, please call to report any unavoidable lateness or absence. INSTRUCTOR will try to arrange a make-up session, schedule permitting. If INSTRUCTOR is absent for any reason, a make-up session will be provided at no additional charge to STUDENT. The INSTRUCTOR'S phone number is (646) 342-1681.
4. STUDENTS are expected to practice regularly, do homework, and come to sessions prepared.

TERMS OF PAYMENT

1. Upon signing this agreement STUDENT shall pay to INSTRUCTOR a non-refundable deposit equal to 20 percent of the total price for the instructional sessions, that amount being \$200.00. Deposit checks and money orders are to be made out to: "George Flowers." This sum shall be applied as payment for sessions nine (9) and ten (10), with the balance to be paid to INSTRUCTOR in equal installments of \$100.00 at the conclusion of each of the first eight (8) weekly sessions. Corporate checks, cash or money orders only; personal checks will not be accepted. Receipts will be provided.
2. Voluntary withdrawal from the instructional sessions does not negate contractual obligations.
