Students will be working in a professional sewing environment using equipment such as sewing machine, scissors, and irons. Equipment use will be monitored at all times, and every effort will be made by our staff to ensure that safety is a top priority and that the proper safety techniques are practiced and enforced by all members and agents of Stitching on State.

**For the safety of all parties participating in services at Stitching on State, please read the terms detailed below, complete all fields below and provide a signature confirming your understanding and agreement to all terms herein.**

1. Students under the age of 18 must have a parent or legal guardian complete registration document and this liability release form before the student or customer will be allowed to participate in activities on the premises.
2. Participation in the use of any of the equipment on the premises is solely at the risk and liability of the student (or parent/legal guardian if under the age of 18).
3. As stated above, every effort will be made by Stitching on State and its agents to ensure safe use of all equipment by students, but due to the potentially dangerous nature of sewing equipment and tools, Stitching on State will not accept liability of any injury or damages that the students may suffer related to the premises of Stitching on State, or activities sponsored by Stitching on State.
4. In the case of injury, any cost incurred from the emergency medical treatment or medical transportation to the hospital will solely be the responsibility of the student (or parent/legal guardian if under the age of 18).
5. Any personal belongings of the student or the legal guardian that enter the premises of Stitching on State remain the sole responsibility of the student or legal guardian. Stitching on State shall not be responsible for lost, stolen or damaged property or belongings.

## Emergency Release and Acknowledgment

I have read, understand and agree to abide by the conditions stated above. I understand that I am participating in activities at Stitching on State at my own risk and liability.
