Annual Meeting, September 9, 2020 Cancelled Board Meeting, October 12, 2020

Because of COVID 19 the SLA Board of Directors were polled and made the decision to cancel the 2020 Annual Meeting scheduled for September 9, 2020. Instead, the board met in person (socially distancing) on October 12th at the Columbia County Administration Building to address issues and make decisions on behalf of the membership. Hopefully, the SLA can meet in 2021 for a "two year" Annual Meeting.

Dennis Benson chose not to run again and Betty Gast resigned from the board in 2020. The bylaws state the SLA should have an eight member board so the directors appointed Jill Pogorelec (South) to fill the one year remaining on the term of Betty Gast. The board also appointed Don Sabey (North) to the board. (The list of Board members and their contact information is given on the last page of the newsletter.)

Jim Watson explained the high water situation and its relation to the weeds in the Fox River. (This information is given in the "Watson Watch" article.) Jim was authorized by the board to purchase another air cooled motor (price not to exceed \$3,000.00) to disturb/cut the weeds starting at the outlet of the Fox River and going towards Portage. Expenditures for gas etc. are also to be brought to the board for reimbursement. With assetstotaling \$26,944.67 at this time the board feels the expenditures are justified to help keep the water levels of Swan Lake satisfactory. This can be done with volunteer involvement.

WATSON WATCH

I want to go over what I reported in the last newsletter about our experiment with thick weed growth down the Fox River and continue with what happened the rest of the season.

At the end of last winter the level of Swan Lake was the lowest it has been in 3 years. It was at our long term, average normal, summertime level. After the ice and snow melt and some spring showers, it rose to 10" above our baseline "normal" level. It should be noted that 24" above that baseline is where the county Slow No Wake order takes effect.

The rains ceased and sunny weather in May had many of us watering lawns and gardens. The dry, dusty weather continued well into June. There was no extra water out of the ordinary flowing from Park Lake and entering Swan Lake So---why did Swan Lake stay at 10" during the dry spell and not drop? Then why did the lake level begin to rise 1/2 to 1 inch per day the last week of May and into the first two weeks of June with zero rainfall? With all the record rains the previous several years (several long lasting high water events each year), groundwater is high and flowing into the rivers and lakes. The wetlands are also saturated and draining into waterways. During winter and spring there are no aquatic plants in the Fox River to hold back water. As the water warms and the sun shines the plants grow rapidly and begin to impede flow. There is no doubt if you watch it day to day.

Unfortunately, I was away from the lake 10 of the 12 days in early June, so I was unable to start our "experiment" until June 19th. By then we were only 3" from the mark for the Slow No Wake ordinance to take effect. It was still rising 1" per day so, by June 23rd we would have reached that mark. Based on past experience, the high water likely would have run through the 4th of July holiday week and for sure if any rainfall occurred.

First, we measured flow at the west end outlet. We had to time small, neutrally buoyant particles as they moved one foot because our flow meter could not turn in that slow, stagnant water. Timing the slow movement at several points across the width of the Fox River, we calculated an average movement of only 0.22 feet per second!

Next, we ran the heavy boat with the air cooled, long tail, mudmotor downstream two miles and back several times. Almost all of that distance the river was completely choked with weeds to within inches of the water surface! In many stretches of the river the surface of the water was not visible at all--only a green mat that birds, turtles, and frogs could walk across without falling in the water.

We drive at a speed to generate the largest wakes possible that knock the plants down and set them wagging back and forth. The water behind the boat fizzles and bubbles as gas bubbles trapped in the mat and tangles of weeds get released. After the first trip the path made by the boat shows water is moving. Multiple trips each day for several days opened up this pathway to a 6-8 foot channel of moving water. The current helps to tip over more weeds on its own. Interestingly, some of the weeds we pulled up by hand were 5-8 ft. long and were wound and tangled like giant dreadlocks.

From that first day, the lake level began to drop 1/2 to1 inch per day depending if there were a few light rain showers. We had to keep after it or weeds that had been knocked over would float back up. Because they were growing inches per day the level would start to rise again. After two weeks there were no matted weeds on the surface at all and much of the river bottom was visible. And, after a month the river flow at the outlet was averaging 0.93 feet per second. That is over 4 times faster than before we started this recorded experiment.

In mid-July we had some heavy rains around the lake but not enough to cause trouble. But, upstream of Pardeeville, a lot more fell, so they had to open the new emergency spillway due to bridge work on Hwy 22. That sent our lake level up, barely touching the Slow No Wake benchmark line, but not over it. We had enough room to catch the water and let that surge pass downriver.

We continued the operation even though the river looked fairly clear. In the first two weeks of August we tried to run up and down the Fox River 6 out of 7 days per week, taking off 1 day. Both of the times we did not run the river the lake rose an inch. So we know it has to be done nearly every day. We totaled over 50 days of running the river by mid-August.

With help from volunteers we could keep this going several days per week and keep the level stable or dropping. Randy Rhode, Jeff Marcouiller and his son, Sawyer, were able to keep the experiment going when I could not. By the third week of August the weed growth slowed and some died off as often happens late in the season. By then the level was down 16". Many people seem to like it at that level--if it gets much lower than that I hear complaints the lake is getting too low!!!???

I feel this experiment was a great success! Therefore, if we start earlier, before weed growth gets too far along, and before the water gets too high, and keep at it on a daily basis, we can avoid some high water and Slow No Wake periods. And/or we can shorten the duration of some of the more extreme events.

If water rises so high above the river weeds and over-tops the lakeshore and river banks to flood the thousands of acres of marsh lands from Pardeeville to Portage, (such as the double slam we got in late August), there is nothing we can do. We had 14 inches of rain right here at the lake and over 18 inches in three days in the upper watershed between Pardeeville and Dalton. I won't go into the wind and tornado damage--everybody could see that. The double surge of water was only topped by what happened in 2008 when the lake rose 72". This storm caused the lake to rise 55"! And, the lake was 16" below our Slow No Wake mark or may have tied the 2008 thousand year flood event. Note how fast the water went down after this event. It was the second highest water level ever and it receded relatively quickly compared to lesser flood events in recent years that sometimes lingered for 6 weeks or more.

Any time the water is 3-4 feet above normal the river weeds mean nothing. The restriction is then the old railroad grade at Portage. It is like a dam and all that water spread over a couple or more thousand acres of marshland has to pass through the narrow, old railroad trestle. A boat ride at that high level shows the water piled up by that trestle. Don't go near it! You don't even have to drive the boat in the river--just go over the bends like the water was doing. Some places I had no idea where the channel was.

Long story I know, but I want everybody to know what we can do. To do more would cost millions of dollars and only send our problems down the river. There are many homes and farms from here to Buffalo Lake. They get hit harder than we do because of the extra input from Neenah Creek, French Creek and many other smaller tributaries. Crops are flooded, homes too, along with the county road bridges closed, etc.

We may need more volunteers next season to spread the workload. The long tail mud motor is a handful and it needs a strong arm to steer it. Call me if you are interested in helping. It is a scenic ride and I enjoy every trip down and back.
