The Ad Hoc Committee will nominate at least three candidates, to be voted in approximately one month from Mar 2, 2023. If anybody would like to nominate a candidate they will recommend them to the nominating committee, to be presented for a vote of the whole committee. Any nominee should be asked if they

would like to join the committee, before bringing them to the entire DTC committee. Candidates can be nominated from the floor on the night of the next meeting. Candidates do not have to be present to be voted on, but do have to be registered Democrat in the town of Canaan. We need a majority of the quorum of the DTC to successfully elect a candidate. Richard Heinz moves to accept the rules as stated, Lonnie Carter seconds the motion. The motion is unanimously passed.
