Upon arrival, tickets must be redeemed at any ticket window and loaded onto a Catamount/Berkshire East RFID card for lift access. If a guest does not already have an RFID card, one must be purchased at time of redemption for \$5. This reloadable card is a one-time purchase per individual, and cards will be valid for multiple years.

**Note:** Bulk Tickets are purchased on a prepaid basis. You must return all unsold tickets by April 12<sup>th</sup>, 2024 to be eligible for credit at the end of the 23-24 season. The credit will carryover and be good toward the purchase of Bulk Tickets for the summer program or following winter season.

- Please allow for a minimum of 3 days to process order.
- Vouchers are valid for one Full Day lift ticket only (opening to 4pm); Night skiing vouchers are valid (3pm to close). Night skiing begins in January. See website(s) for exact hours of operation.
- Payment must be made before any ticket orders will be fulfilled.
- There are no refunds, exchanges, or substitutions for sold vouchers.
- Catamount & Berkshire East are not responsible for any damaged, stolen or lost vouchers.
- All unused vouchers must be returned to the Director of Business Development by April 12, 2024 to be credited for the upcoming summer season program or following winter season.
- Season-end credit is based on total vouchers ordered, total vouchers returned, and payments made.
