Trip Agreement Form, Waiver and Refund Policy

- 1. Each participant shall <u>read</u> and completely fill out all parts of the Trip Form.
- 2. Each participant shall submit a completed Trip Form with a deposit to confirm his/her reservation.
- 3. Each participant shall be a current member, or child of a member of the G E Ski Club Inc. (The Club). Any children on a trip MUST be with their parent(s) or legal guardian who are club members.
- 4. All deposits and payments should be in by dates or deadlines published for each trip or event.
- Each reservation, made either at the regular meeting or by postmarked correspondence, is on a firstcome, first-served basis.
- 6. Make all checks **payable to G E Ski Club**. Send to PO Box 327, New Hartford NY 13413-0327 Attn:Trips. Write trip name on check memo line. Returned checks for LACK OF FUNDS will incur a \$30.00 charge.
- 7. Each participant shall list roommates or children. If roommate listed does not sign up, one will be assigned as best as can be arranged. If no roommate is found or is refused, single \$ rates may apply.
- Each participant is completely and individually responsible for his or her own, or their accompanying children's, actions during all trips or events and bears the burden of liabilities thereof.
- 9. Each participant (and accompanying children) holds The Club and officers harmless and waives all right of regress for any liability whatsoever that may arise during the course of a trip or event. Each participant and heirs know and agree, that any sport, event, or trip is inherently hazardous and as such could result in PERSONAL CATASTROPHIC INJURY, DEATH, OR PROPERTY DAMAGE; and that they or their accompanying children, do participate at their own risk. The participants' release the club from any and all liability per the signed membership application and by signing this agreement & waiver.

CANCELATION and Refund Policy

- 1. The Club reserves the right to cancel any trip or event at any time for any reason. In that case, the Club will make every effort to recover monies paid out to vendors and refund to participants per this policy.
- 2. Each participant is responsible for the individual cost of any trip they have signed up for and do not show.
- 3. Any participant who has made a deposit and has to cancel <u>prior</u> to the first deposit Date/Deadline will receive a refund.
- 4. If a participant cancels after the first deposit Date/Deadline, the participant is responsible for any administrative costs and trip expenses incurred by the club on their behalf for said trip. If applicable, any monies that can be recouped from vendors or others will be refunded per refund policy.
- 5. Any refunds due for a participant cancellation after the first deposit Date/Deadline, or event/trip cancelled by the club, or for any other reason, can be <u>declared within thirty days</u> and <u>paid within sixty days</u> of the trip's **scheduled completion date.**
