As Permanent Jewelry (PJ) is custom cut and designed for me, I acknowledge that ALL SALES ARE FINAL. Elise Orion, LLC will do everything in their power to ensure my jewelry is securely welded before I leave the store, but I also know that sometimes life happens! If my permanent jewelry breaks at the weld spot within 7 days, I may return the chain for repair of the weld at no charge. By nature, PJ is offered in a variety of dainty products to ensure my safety as well as provide an opportunity to stack multiple jewelry items so that I can capture more than one special moment. I understand that PJ refers to items that do not require a clasp for closure but does not mean the item is indestructible. I acknowledge that Elise Orion, LLC does NOT offer full replacements or refunds for broken or lost chains. Mfg. defects are covered for 30 days. If my jewelry breaks due to lifestyle, job or other factors outside of Elise Orion, LLCs control, I may bring the broken chain back to the store and they will be happy to assist in repairing the item, if possible, for a small charge. I understand that I may purchase a separate jewelry insurance policy for lost jewelry from any 3rd party vendor at my own expense.

- _____ The jewelry is intended to be permanently closed, and removal may require professional assistance.

- _____ I have been provided and read the aftercare and maintenance instructions provided and understand the composition of the product that I am purchasing.
- _____ I agree to follow the aftercare instructions to minimize any risks of complications and to prolong the life of my jewelry.
- _____ I confirm that I am 18 years of age or older, or I am between 13-17 years of age and have been accompanied by a parent/legal guardian who has the authority to provide consent to the attachment of PJ to my person.
