The Behind-The-Wheel Driving Instruction requires submitting a Certificate of Completion from an approved online provider and a \$630.00 tuition payment for EIGHT hours of practical behind-the-wheel instruction which is based on the Ohio Driver Training Curriculum. Prices are guaranteed if the program is completed within 60 days. An additional fee will be charged for a returned check.

If requested by the student and only if approved by the instructor, the instructor will take you to the license station, review procedures and take you home, at the rate of \$59.06 per unit. Two or more units of driving adult or teen instruction is at the rate of \$59.06 per unit. (Units are 45 minutes in length).

Driver training schools are licensed by the Department of Public Safety through the Driver Training Program Office, 1970 West Broad Street, Columbus, Ohio 43223. The driving school shall furnish a licensed instructor and a motor vehicle for instruction. By state law, driving schools are not permitted to guarantee the issuance of a driver's license to the student. State regulations prohibit more than FOUR hours of training to be conducted in one day.

Notice of cancellation of Behind-The-Wheel lessons **must** be given by the student to the school three (3) or more business days in advance of the lesson. Failure to cancel may result in the student being charged the rate of \$59.06 per unit. AAAA International Driving School of Milford LLC reserves the right to cancel this agreement at any time, should the student or parent's conduct indicate a lack of responsibility deemed necessary by the drivingschool.

If the school is prepared to meet its obligations under this agreement, refunds will not be provided. Both the parent or guardian and the student are equally responsible for fulfilling the terms of this agreement. **READ BELOW FOR OTHER IMPORTANT AGREEMENTS.**

### **Partial Invalidity**

If any provision of this agreement is held by a court of competent jurisdiction to be invalid, void, or unenforceable, the remaining provisions shall nevertheless continue in full force without being impaired or invalidated in any way.

### **Privacy Policy**

Your privacy is very important to us. Accordingly, we have developed this Policy for you to understand how we collect, use, communicate, disclose and make use of personal information. The following outlines our privacy policy. Before or at the time of collecting personal information, we will identify the purposes for which information is being collected. We will collect and use personal information solely with the objective of fulfilling those purposes specified by us and for other compatible purposes, unless we obtain the consent of the individual concerned or as required by law. We will only retain personal information necessary for the fulfillment of those purposes. We will collect personal information by lawful and fair means and, where appropriate, with the knowledge or consent of the individual concerned. We will protect personal information by reasonable security safeguards against loss or theft, as well as unauthorized access, disclosure, copying, use or modification. We are committed to conducting our business in accordance with these principles to ensure that the confidentiality of personal information is protected and maintained.

### **Refunds and Completion**

No refunds will be issued should the school be ready to fulfill its part of the agreement. The Driving School shall furnish a Certificate of Completion to all students under the age of eighteen years, who successfully complete the course. Completion, as defined by the State of Ohio, refers to the completion of the required number of hours, the student's good faith effort having been exercised during the practical driving portion, and the attainment of a score equal to or greater than 75% on the performance measurement. Should Student fail to achieve the minimum passing score on the final exam additional classroom attendance may be required.

### **Media Release**

Photographs, recordings, or electronic media may be collected and utilized for promotional purposes. AAAA International Driving School, Inc., AAAA International Driving School of Mason, LLC, and AAAA International Driving School of Milford, LLC are hereby granted the right to take photographs of all students, former, current, and prospective, in connection with any and/or all driving school classes or events. ### **Tuition, Fees, and Payments**

All FEES must be paid with cash, check or Square online portal. When you book lessons, you have a tentative appointment. We confirm behind the wheel lessons once your student has a) paid in full, b) has a Certificate of Completion and c) has their temporary driver's license. If you would like to cancel or reschedule a Behind-The-Wheel appointment, we require three FULL business days (Monday through Friday) notice. If you do not give THREE FULL business days' notice, you will be assessed a \$59.06 cancellation fee. If a student misses a behind-the-wheel appointment, wears inappropriate shoes, or forgets their temporary license, the lesson will be canceled, and a \$56.25 fee is required before rescheduling.

### **Miscellaneous Agreements**

If the student or their instructor is not confident in the student's highway car control ability, we will reschedule the final behind the wheel lesson. Processing your certificate may require up to three business days after your final lesson.

### **Indemnification**

Student and his/her parents and/or guardians shall indemnify and hold AAAA International Driving School, Inc., AAAA International Driving School of Mason, LLC, AAAA International Driving School of Milford, LLC its employees, shareholders, agents, representatives, officers, trustees, successors and assigns, harmless from any and all claims arising out of any damage to person or property occurring as a result of student's own negligent or intentional conduct.
